ORDER TO SHOW CAUSE

WHEREAS, on February 6, 1970, Roy A. Schell filed an application to appropriate 4.80 cubic feet per second of groundwater to be diverted from a point within the SE $\frac{1}{4}$ SE $\frac{1}{4}$, Sec. 28, Twp. 12S, Rge. 21E, B.M., Cassia County, to be used for irrigation purposes for 240 acres of land within the NE $\frac{1}{4}$ SW $\frac{1}{4}$, S $\frac{1}{2}$ SW $\frac{1}{4}$, Sec. 27; N $\frac{1}{2}$ SE $\frac{1}{4}$, SE $\frac{1}{4}$ SE $\frac{1}{4}$, Sec. 28; All in Twp. 12S, Rge. 21E, B.M.; and,

WHEREAS, the application was approved by the Department on March 13, 1970, and Permit No. 45-7046 was issued; and,

WHEREAS, the permit indicates that the property at the point of diversion and the place of use is administered by the U.S. Bureau of Land Management and the applicant has a desert land entry application with the Bureau of Land Management; and,

WHEREAS, on April 16, 1976, the Department requested that the applicant submit evidence of the desert land entry filing and, has to date, failed to respond; and,

WHEREAS, it appears that the permit may have been filed for purposes of speculation since the applicant has not shown a possessory interest in the land as described under said permit;

IT IS, THEREFORE, HEREBY ORDERED that the present permit holder, Norman and Wanda Thompson, show cause before the Director of the Department of Water Resources on or before June 4, 1976, why Permit No. 45-7046 should not be CANCELLED for grounds of speculation as provided by Section 42-203, Idaho Code.
