


RENTAL AGREEMENT CONDITIONS OF ACCEPTANCE

- 1. The use of water under this agreement shall be subject to the provisions of Idaho Code § 42-1766.
- Rental of the specified right from the bank does not, in itself, confirm the validity of the right or any elements of the water right, or improve the status of the right including the notion of resumption of use. It does not preclude the opportunity for review of the validity of this water right in any other department application process.
- 3. Use of water under this agreement does not constitute a dedication of the water to renter's place of use, and upon expiration of this agreement, the points of diversion and place of use of the water shall revert to those authorized under the water right and/or again be available to rent from the bank.
- 4. Use of water under this agreement shall not prejudice any action of the Department in its consideration of an application for transfer or permit filed by the applicant for this same use.
- 5. Renter agrees to comply with all applicable state and federal laws while using water under this agreement.
- 6. Renter agrees to hold the Board, the Director and the state of Idaho harmless from all liability on account of negligent acts of the renter while using water.
- 7. Renter acknowledges and agrees that the Director may terminate authorization for the use of a water right based on a water right's priority date.
- 8. This right when combined with all other rights shall provide no more than 0.02 cfs per acre, nor more than 4.0 afa per acre at the field headgate for the irrigation of the place of use.
- 9. Use of water under this rental may be regulated by a watermaster with responsibility for the distribution of water among appropriators within a water district. At the time of this approval, this rental is within State Water District 120.

- Upon specific notification of the Department, the renter shall install and maintain data loggers to record water usage information at the authorized point(s) of diversion in accordance with Department specifications.
- 11. Prior to the diversion and use of water under this rental agreement, the renter shall install and maintain acceptable measuring device(s) at the authorized point(s) of diversion in accordance with Department specifications, or shall obtain an approved variance from the Department to determine the amount of water diverted from power records or to maintain an existing measuring device.
- 12. This rental does not grant any right-of-way or easement to use the diversion works or conveyance works of another party.
- 13. This rental agreement does not authorize the construction of a well.
- 14. Pursuant to Idaho Code § 42-1412(6), the water rights rented on this agreement are subject to such general provisions necessary for the definition of the rights or for the efficient administration of water rights as determined by the Snake River Basin Adjudication court in the final unified decree entered 08/26/2014.



Based on the shapefiles provided it appears the remaining acreage is approximately 98.4 acres of which LCSC will need to delineate the 82.4 acres they intend to irrigate. The best way for that to happen will be for LCSC enterprises to provide us with shapefiles or maps of where they intend to irrigate during 2020. Attached shapefile and 2017 aerial imagery showing the area we would like to cover with the existing water rights and rental. Based on my delineation of the 2017 aerial there is a total of 783.8 acres of cultivated and

system watered land. The existing water rights authorize 708 acres (35-7616A: 82 ac; 35-7491: 336 ac; 35-7740: 290 ac).

There has been alot of variation in calculated acreages depending on what year aerial is examined and who performs the delineation so we are requesting the 82.4 acres (approximately 10% over my actual delineated need) in order to be absolutely certain there will be no violation regardless of windblown irrigation and overspray. Transfer application 82434 will not be approved this year and should be disregarded for purposes of this rental.

Please approve the rental as quickly as possible at whatever acreage you believe is appropriate in order to cover the land irrigated as shown in the attached 2017 aerial photo.

Time is of the essence and it is still critical that this be approved as quickly as possible. I don't know how to stress this more emphatically.

Purpose/Narrative: An application was received on behalf of LCSC Enterprises by their representative on March 11, 2020 as part of a proposed lease/rental package involving PEP and the City of Chubbuck. Initially this application was part of a four application package however, per three recently approved transfers, two were no longer necessary and the fourth was returned.

The application is proposing to irrigate acreage that is outside the authorized place of use for both the water rights held by LCSC and the pending transfers, 83288, 83315 and 83340, slated to be approved by IDWR in May 2020. The applicant had requested a total of 59.3 acres but because the transfers are being approved, has been reduced to 48.4 acres and the remainder will be covered by a permanent water right held by LCSC.

Authority to File: These applications were signed by Mr. Blair Dance as a registered agent for LCSC Enterprises. Per the information provided in the previous lease application, LCSC Enterprises is a subsidiary of Borah Capital LTD of which Mr. Dance is a registered agent. No concerns at this time.

Water Right Validity/Forfeiture Evaluation: The water rights being requested are currently leased to the Bank and available for lease. These rights are held by Glen Ward Livestock and have been leased to the Bank previously. No concerns at this time.

Injury Evaluation: No injury is apparent through the rental, ESPA modeling was provided by the applicant's representative using the previous version of the ETRAN indicating mitigation was not necessary. The data was verified using the most current version and no mitigation is required.

The water rights to be rented are located just outside of the ESPA GWMA boundary. Part of the rental POU is within the ESPA. The rental was modeled using the closest grid cells within the model boundary.

At first glance there may be concern that there is a change from one distinct aquifer to a totally separate aquifer proposed in the rental, because the water rights to be rented are outside of the ESPA and are thus not considered part of the common ESPA aquifer source. However, the rights to be rented are less than a mile from the digital boundary which is itself an approximation of a physical reality. Guidance from Jeff Peppersack (New ESPA Transfer Spreadsheet V2.1, Jeff Peppersack, 2006) says that:

"Transfers moving from the ESPA modeled area to a location outside the modeled area (or from outside to within the modeled area) need to be reviewed carefully because a transfer cannot be approved to move from one distinct aquifer to a totally separate aquifer...For points of diversion between the ESPA and just outside the ESPA modeled area, it may be reasonable to to allow use of the closest cell within the ESPA modeled are for analysis using the transfer spreadsheet and ignore other tributary effects."

And the following:

"Transfers between the ESPA modeled area and non-modeled tributary aquifers will require separate analysis by other acceptable methods unless the distance is less than 2 cells outside the modeled area."

Therefore, use of the closest model cell in this case is justified and we do not consider rental to be a change in aquifer source.

Enlargement of Use: No enlargement is evident as the rental will be calibrated to match the water rights at the rental place of use. No concerns at this time.

Local Public Interest: Sustainable management of water throughout this basin is in the local public interest. As such, comments will be requested from the staff of Water District 120, and IDWR's Eastern Region office.

Beneficial Use/Conservation of Water Resources: The beneficial use of irrigation is consistent with the conservation of water throughout the State of Idaho.

Department/Watermaster Comments: Water District 120 and IDWR Eastern Region comments were requested May 28, 2020

Water Supply Bank Evaluation: Subject to favorable water district and regional office comments, it is recommended this rental be approved for a single year through the end of 2020. Note rental fees are based on the more specific (not rounded) rental volume of 193.60 af so they are required to pay \$3,872.00 instead of \$3,880.00.
