RENTAL AGREEMENT CONDITIONS OF ACCEPTANCE

- 1. The use of water under this agreement shall be subject to the provisions of Idaho Code § 42-1766.
- 2. Rental of the specified right from the bank does not, in itself, confirm the validity of the right or any elements of the water right, or improve the status of the right including the notion of resumption of use. It does not preclude the opportunity for review of the validity of this water right in any other department application process.
- 3. Use of water under this agreement does not constitute a dedication of the water to renter's place of use, and upon expiration of this agreement, the points of diversion and place of use of the water shall revert to those authorized under the water right and/or again be available to rent from the bank.
- 4. Use of water under this agreement shall not prejudice any action of the Department in its consideration of an application for transfer or permit filed by the applicant for this same use.
- 5. Renter agrees to comply with all applicable state and federal laws while using water under this agreement.
- 6. Renter agrees to hold the Board, the Director and the state of Idaho harmless from all liability on account of negligent acts of the renter while using water.
- 7. Renter acknowledges and agrees that the Director may terminate authorization for the use of a water right based on a water right's priority date.
- 8. Failure of the renter to comply with the conditions of this agreement is cause for the Director to rescind approval of the rental agreement.
- 9. This right when combined with all other rights shall provide no more than 0.02 cfs per acre nor more than 4.0 afa per acre at the field headgate for irrigation of the place of use.
- 10. Use of water under this right may be regulated by a watermaster with responsibility for the distribution of water among appropriators within a water district. At the time of this approval, this water right is within State Water District No. 120.

- 11. Prior to the diversion and use of water under this rental agreement, the renter shall install and maintain acceptable measuring device(s) at the authorized point(s) of diversion in accordance with Department specifications, or shall obtain an approved variance from the Department to determine the amount of water diverted from power records or to maintain an existing measuring device.
- 12. Pursuant to Idaho Code § 42-1412(6), this water right is subject to such general provisions necessary for the definition of the rights or for the efficient administration of water rights as determined by the Snake River Basin Adjudication court in the final unified decree entered 08/26/2014.
- 13. Prior to December 31 of each year, the Board may review this rental agreement to determine whether it is consistent with the management plan that may be approved for the Eastern Snake Plain Aquifer Ground Water Management Area ("ESPA GWMA Plan") pursuant to Idaho Code § 42-233b. The Board may cancel this rental agreement if the Board determines it is not consistent with the ESPA GWMA plan. If this rental agreement is canceled, the cancellation shall not take effect until December 31 of the year in which the rental agreement is canceled.
- 14. This rental agreement does not authorize the construction of a well.





- 1. Use of water under this agreement shall not prejudice any action of the Department in its consideration of an application for transfer or permit filed by the applicant for this same use.
- 2. Renter agrees to comply with all applicable state and federal laws while using water under this agreement.



Purpose/Narrative: A second application was received from Heritage Farms LLC as part of a lease/rental package on March 2, 2020. This rental, similar to application 1471, seeks to continue the irrigation of acres not covered by a water right. The place of use is adjacent to a water right held by Heritage Farms LLC however, the place of use for the water right excludes the corners of the acreage. This rental appears to have started initially in 2017 through 2018, then 2019 through 2020, and has been proposed to end in 2023. The rental term has been matched to the term requested by the lessor of the water right being used and appears to have initially started as a result of an NOV issued by the Department (E2017-1109).

Review of the prior applications indicate that the acreage being requested is the adjusted amount to provide a 4.0 af/a at the rental location. More acreage and volume are necessary to rent such that the rate and volume per acre can be adjusted higher.

Authority to File: The applications were signed by Mr. Driscoll, review of the Idaho Secretary of State information indicates Mr. Driscoll is a member of Heritage Farms LLC. No concerns at this time.

Water Right Validity/Forfeiture Evaluation: The water right being requested has been leased to the Bank and remains valid. No concerns at this time.

Injury Evaluation: No injury is apparent through this rental. The applicant has submitted Eastern Snake River Plane Aquifer (ESPA) modeling as part of the application package indicating mitigation is not necessary. The modeling has been verified using the most current version of the software and no mitigation is required based on the amounts being requested.

Enlargement of Use: No enlargement is evident through the rental, as the rental is seeking to extend the place of use for an existing water right, the rental will be matched to the same rate per acre and volume per acre. Both this rental and the water right being supplemented will be limited to 0.02 cfs/ac and 4.0 af/ac. The area is not within an irrigation district and, as such, will not receive water from another source other than this rental.

Local Public Interest: Staff are unaware of any local public interests that are averse to the rental.

Beneficial Use/Conservation of Water Resources: The rental appears consistent with the conservation of water resources in Idaho.

Department/Watermaster Comments: Watermaster and IDWR Eastern Region comments were requested on April 14, 2020

Water Supply Bank Evaluation: Bank staff recommend the approval of this application
