

The right holder shall not provide water diverted under this right for the irrigation of land having appurtenant surface water rights as a primary source of irrigation water except when the surface water rights are not available for use. This condition applies to all land with appurtenant surface water rights, including land converted from irrigated agricultural use to other land uses but still requiring water to irrigate lawns and landscaping.
- 12. This right is for the use of trust water, and it is subject to review 20 years after its initial approval (date of permit approval) to re-evaluate the availability of trust water for the authorized use and to re-evaluate the public interest criteria for reallocating trust water.
- 13. When the minimum stream flow water rights in the Snake River at Murphy Gage are not being satisfied, the right holder shall cease diverting water for the consumptive uses authorized by this right. The minimum stream flow water rights are for 3,900 cfs from April 1 through October 31 and 5,600 cfs from November 1 through March 31. See IDAPA 37.03.08.030.
- 14. The right holder shall accomplish the change authorized by this transfer within one year of the date of this approval.
- 15. Failure of the right holder to comply with the conditions of this transfer is cause for the Director to rescind approval of the transfer.

# **PETITION FOR RECONSIDERATION**

Any party may file a petition for reconsideration of a preliminary order with the department within fourteen (14) days of the service date of this order. Note: the petition must be <u>received</u> by the department within this fourteen (14) day period. The department will act on a petition for reconsideration within twenty-one (21) days of its receipt, or the petition will be considered denied by operation of law. See Section 67-5243(3) Idaho Code.

# **EXCEPTIONS AND BRIEFS**

Within fourteen (14) days after: (a) the service date of a preliminary order, (b) the service date of a denial of a petition for reconsideration from this preliminary order, or (c) the failure within twenty-one (21) days to grant or deny a petition for reconsideration from this preliminary order, any party may in writing support or take exceptions to any part of a preliminary order and may file briefs in support of the party's position on any issue in the proceeding with the Director. Otherwise, this preliminary order will become a final order of the agency.

Application for transfer proposes to combine all of the eleven existing wells that serve the Sun Valley Water & Sewer District municipal water supply system by listing the wells as points of diversion (POD) on the District's seven municipal water rights which have a combined flow rate of 18.70 cfs. In addition, a new well will be drilled at a point approximately 0.3 mile southwest of the intersection of Saddle Road and Sun Valley Road in Sun Valley, and it will also be listed as a POD on all seven rights (12 wells total).

Because the transfer involved changing and adding PODs, it was advertised and public comment was sought. No protests were received. The transfer is located within WD-37 and Watermaster comments were solicited. The Watermaster did not comment on the transfer.

# • Authority to File:

The Department's database indicates that water rights 37-2722, 37-7102, 37-21151, 37-21465, 37-22444, 37-22445, and 37-22447 are owned by the applicant, Sun Valley Water & Sewer District. The application was signed by Pat McMahon, the general manager of the Sun Valley Water & Sewer District. He was granted authorization to sign by the Board of Directors of the Sun Valley Water & Sewer District in a written document included with the transfer application.

• Water Right Validity:

Rights 37-2722, 37-7102, 37-22444, 37-22445, and 37-22447 were decreed in the SRBA in 2010, while right 37-21151 was licensed in 2012 and right 37-21465 was licensed in 2019. Recent water usage data is recorded in the Water Management Information System (WMIS) for SVW&SD, so forfeiture is not likely an issue.

Injury to Other Water Rights:

None anticipated or foreseen. The addition of another POD to the SVW&SD system will not come with an increase in diversion rate.
