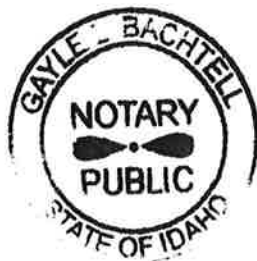

The Department of Water Resources (Department) acknowledges the receipt of correspondence changing ownership of the above referenced water right(s) to you. The Department has modified its records and has enclosed a computer-generated report for you.

If in the future, Kaylin Dennis wishes to legally change her name on these water rights; the department can make that change with a signature from her, along with a copy of the legal documentation showing the name change. Please note, since Kaylin is already a current owner on the water rights, there is no fee required make this change. We were not able to make that change with the Quitclaim Deed provided; as it lists her name as Kaylin Dennis-Thompson.

Updating the ownership record for a water right does not reconfirm the validity of the right. When processing a Notice of Change in Water Right Ownership, the Department does not review the history of water use to determine if the right has been forfeited or deliberately abandoned through five years or more of non-use.
