- 1. X27 This right is limited to the irrigation of 5.2 acres within the authorized place of use in a single irrigation season.
- 2. X35 Rights 34-14804, 34-14805, 34-14806 and 34-14807 when combined shall not exceed the irrigation of 12.2 acres.
- 3. X35 Rights 34-14804, 34-14805, 34-14806, 34-14807 and 34-14808 when combined shall not exceed a total diversion rate of 0.27 cfs and the irrigation of 13.5 acres.
- 4. R05 Use of water under this right will be regulated by a watermaster with responsibility for the distribution of water among appropriators within a water district. At the time of this approval, this water right is within State Water District No.34.
- 5. R43 The right holder shall maintain a measuring device and lockable controlling works of a type approved by the Department in a manner that will provide the watermaster suitable control of the diversion(s).
- 6. R63 This right when combined with all other rights shall provide no more than 0.02 cfs per acre nor more than 3.5 afa per acre at the field headgate for irrigation of the lands above.
- 7. Water delivered through the Sutter ditch.

- 10. T07 The right holder shall accomplish the change authorized by this transfer within one year of the date of this approval.
- 11. T08 Failure of the right holder to comply with the conditions of this transfer is cause for the Director to rescind approval of the transfer.
- 12. T19 Pursuant to Section 42-1412(6), Idaho Code, this water right is subject to such general provisions necessary for the definition of the rights or for the efficient administration of water rights as may be determined by the Snake River Basin Adjudication court at a point in time no later than the entry of the final unified decree.
