PRELIMINARY ORDER VOIDING PERMIT

This matter having come before the Idaho Department of Water Resources (Department), the Department makes the following Findings of Fact and Conclusions of Law and Order:

FINDINGS OF FACT

- 1. On July 16, 1982, the permit holder applied to the Department for a permit to appropriate 0.15 cubic feet per second of wastewater within the $NW_4^{1}SW_4^{1}$, Section 03, Township 14S, Range 22E, B.M., Cassia County, to be used for irrigation purposes.
- 2. On September 29, 1982, the Department approved the application and issued Permit No. 45-07509.
- 3. On April 1, 1985, the permit holder submitted Proof of Beneficial Use for Permit No. 45-07509.
- 4. On six different occasions from 1987 to 1996, Department personnel attempted to contact the permit holder to schedule a field examination to verify water use. On each occasion, the examiner was informed that the permit holder had not diverted water and applied it to a beneficial use as authorized by Permit No. 45-07509.
- 5. On October 2, 1996, the Department sent the permit holder a letter giving the permit holder thirty days to submit information demonstrating that a beneficial use of water had been developed under Permit No. 45-07509. The department did not receive a reply.

CONCLUSIONS OF LAW

1. Section 42-219, Idaho Code, states:

In the event that the Department shall find that the applicant has not fully complied with the law and the conditions of the permit, it may issue a license for that portion of use which is in accordance with the permit, or may refuse issuance of a license and void the permit.

- 2. Examination by the Department found that no beneficial use of water was developed under Permit No. 45-07509.
- 3. The Department should void the permit pursuant to Section 42-219, <u>Idaho Code</u>.

ORDER

IT IS THEREFORE, HEREBY ORDERED that Permit No. 45-07509 is **VOIDED** and issuance of a license is **REFUSED** under Section 42-219, <u>Idaho Code</u>.






