This office reviewed the request for extension of time you submitted to the Department in connection with the above-referenced permit. We regret that under the provisions of Section 42-204, <u>Idaho Code</u>, we cannot approve the request because the request indicates that no work has been accomplished toward the development of a water right.

You are also hereby notified that under the provisions of Section 42-218a of the Idaho Code, Permit No. 47-7424 has lapsed since the Department could not approve the request for extension of time you submitted and the project was not complete enough to submit the statement of beneficial use.

I suggest that you file a new application within one year of the time you actually intend to develop a water right. Since Idaho is now under a mandatory permit procedure to develop a water right, the new application will provide an additional period of time for development, although the priority date will be later in time.
