- b. Proof of construction of works and application of water to beneficial use shall be submitted on or be fore <u>November 1</u>, 19 <u>83</u>.
- c. The rate of diversion, if water is to be used for irrigation under this permit, when combined with all other water rights for the same land shall not exceed 0.02 cubic feet per second for each acre of land.
- d. Other: An access port or other device as specified by the Department shall be installed by the permit holder to provide for the isntallation of measuring equipment and the determination of the rate of diversion by the Department.
