WHEREAS, on December 18, 1975 Anne Clark applied to the Department of Water Resources for a permit to appropriate 6.4 cubic feet per second of water from a groundwater source to be diverted within the NW1/4SE1/4, Section 33, Township 12 South, Range 21 East, B.M., Cassia County, to be used for irrigation purposes in connection with a Desert Land Entry; and,

WHEREAS, on December 30, 1985, the Desert Land Entry was classified unsuitable for entry by the Bureau of Land Management; and,

WHEREAS, on February 6, 1986, the Department corresponded with the applicant requesting evidence to show possessory interest in the proposed place of use; and,

WHEREAS, the Department received no response to its inquiry; and,

WHEREAS, the provisions of Section 42-203(A), Idaho Code, provides the Director of the Department of Water Resources may deny Applications for Permit which have been filed for speculative purposes; and,

WHEREAS, lack of possessory interest in the proposed place of use is speculative in nature;

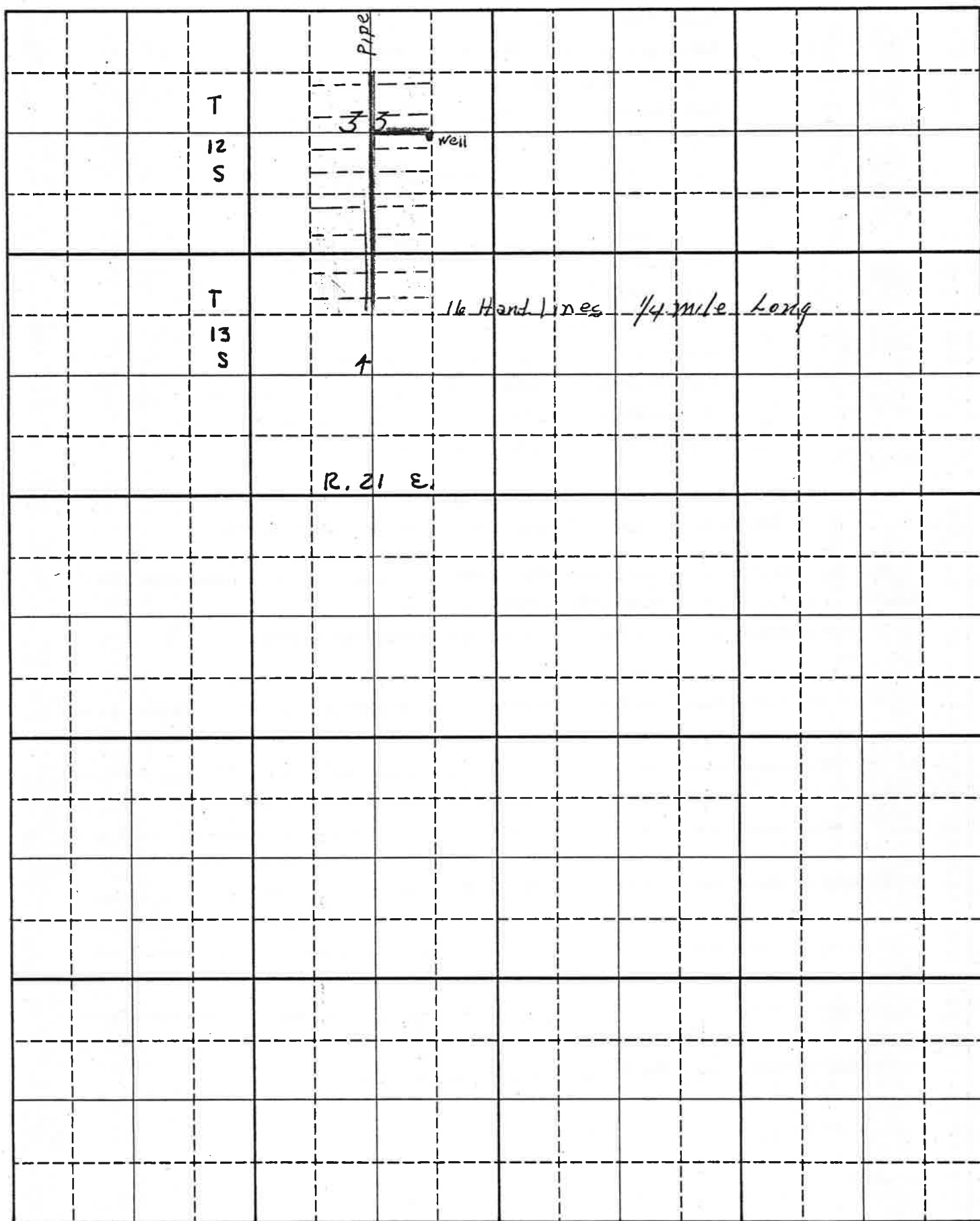
