ORDER

WHEREAS, on January 14, 1975, Mary Jane Ellsworth applied to the Department of Water Resources for a permit to appropriate 1.6 cfs of water from a groundwater source, with the point of diversion in the NE $\frac{1}{4}$ NE $\frac{1}{4}$, Sec. 25, Twp. 13S, Rge. 21E, B. M., Cassia County to be used for irrigation purposes, in connection with a Desert Land Entry; and

WHEREAS, the Department of Water Resources found that no Desert Land Entry has been filed with the Bureau of Land Management for the lands covered by this application; and


WHEREAS, the applicant has no possessory interest in said land; and

WHEREAS, on February 09, 1979, the applicant was sent, by certified mail a notice stating that the application would be voided for lack of possessory interest unless cause was shown on or before March 14, 1979, why said action should not be taken; and

WHEREAS, the applicant has not shown cause why said application should not be voided;

IT IS, THEREFORE, hereby ordered that Application for Permit No. 45-7223 be VOIDED due to lack of possessory interest in the lands covered under said application.
