WHEREAS, on January 3, 1975, Mary Ellen Watterson applied to the Department of Water Resources for a permit to appropriate 6.4 cfs of water from a groundwater source, with the point of diversion in the NE $\frac{1}{4}$ NE $\frac{1}{4}$, Sec. 3, Twp. 13S, Rge. 21E, B. M., Cassia County to be used for irrigation purposes, in connection with a Desert Land Entry; and

WHEREAS, the Department of Water Resources found that no Desert Land Entry has been filed with the Bureau of Land Management for the lands covered by this application; and


WHEREAS, the applicant has no possessory interest in said land; and


