WHEREAS, on December 4, 1974, Barbra Molder applied to the Department of Water Resources for a permit to appropriate 6.4 cfs of water from a groundwater source, with the point of diversion in the NELNEL, Sec. 10, Twp. 13S, Rge. 21E, B. M., Cassia County to be used for irrigation purposes, in connection with a Desert Land Entry; and

WHEREAS, the Department of Water Resources found that no Desert Land Entry has been filed with the Bureau of Land Management for the lands covered by this application; and

WHEREAS; the applicant has not shown cause why said application should not be voided;


IT IS, THEREFORE, hereby ordered that Application for Permit No. 45-7210 be VOIDED due to lack of possessory interest in the lands covered under said application.
