PROPOSED AMENDMENT OF WATER PERMIT

15-7444

Double D Farms, LLC, 2333 WEST 500 SOUTH, MALAD ID 83252, filed an application to amend permit no. 15-7444 on 5/8/20. The permit authorizes the diversion of 0.29 cfs from ground water for the irrigation of 19.5 acres. The applicant proposes to amend the permit by changing the point of diversion to NWSW Sec 14 T14S R35E and by changing the place of use to NWNW, SWNW, and NWSW Sec 14 T14S R35E. The amendment proposes to combine permits 15-7444 and 15-7443 into a 59.5-acre combined place of use. Permit 15-7444 will be limited to 19.5 acres within the combined place of use.

Permits will be subject to all prior water rights.
