PRELIMINARY ORDER
VOIDING APPLICATION
FOR PERMIT

This matter having come before the Idaho Department of Water Resources (Department) as a requirement of Section 42-204, Idaho Code, the Department finds, concludes and orders as follows:

FINDINGS OF FACT

1. Application for Permit No. 43-07165 proposes the diversion of 1.0 cfs from Raft River, tributary of Snake River, for commercial, stockwater and storage purposes.

2. The Department corresponded with the applicant on December 9, 1993, and requested additional information concerning the proposed project.

3. The applicant has not responded to the request for additional information.

CONCLUSIONS OF LAW

1. Section 42-204, Idaho Code, specifies that failure on the part of the applicant to supply requested information within thirty (30) days is cause for the Director to void an application.

2. The Department should void the application as provided in Section 42-204, Idaho Code.
