**NOTICE OF  
PRE-HEARING CONFERENCE**

On May 20, 2019, JARRED AND JESSICA HOLZ, filed an Application for Transfer No. 83543 with the Idaho Department of Water Resources (department). Protest(s) were filed by NANCY MILLER and DAVE RENBERG. The Protest from Dave Renberg was rejected on January 6, 2020, but a Petition to Intervene was granted on February 24, 2020.

The department has scheduled the matter for a pre-hearing conference on **Thursday, June 11, 2020, beginning at 1:00 PM**, at 2200 Michigan Avenue, Orofino, ID 83544. Park in the Main Parking Lot of the DMV (on left) and enter main entrance, down hallway to meeting room.

The pre-hearing conference will be conducted in a facility that satisfies the accessibility requirements of the Americans with Disabilities Act. This change was made to accommodate proper social distancing. Please consider wearing a mask and we will provide hand sanitizer for the meeting.


