Examination of Idaho Department of Water Resources (IDWR) records indicates that we have an active water right transfer application, # 78325, filed in your name. The application was filed with IDWR on February 26, 2004 and proposes to change the authorized point of diversion location for the subdivision's groundwater right, 37-2557Y, from its current location in Bellevue Farms Subdivision to a new well to be drilled on Lot 9B, Block 2 of Eastfield at Bellevue Farms Subdivision. The application was protested on April 20, 2004 by the Bellevue Farms Homeowner's Association. Examination of the file indicates that there has been no apparent action by you or the Bellevue Farms Homeowner's Association to resolve this matter since the filing of the protest in 2004.
