**DEFAULT ORDER**

On May 13, 2020, the Idaho Department of Water Resources ("Department") served a *Notice of Proposed Default Order* to Thomas DeShazo and/or Castle Creek Ranch LLC proposing an order dismissing their protest of Application for Transfer of a Water Right No. 83238 ("Application") for failure to receive a timely response to an information request made on April 28, 2020, in this contested matter.

Pursuant to Rule 701 of the Department's Rules of Procedure (IDAPA 30.01.01.701), Thomas DeShazo and/or Castle Creek Ranch LLC had seven (7) days after the service of the *Notice of Proposed Default Order* to file a written petition requesting that a default order not be issued.

Thomas DeShazo and/or Castle Creek Ranch LLC did not respond to the *Notice of Proposed Default Order*.

Rule of Procedure 702 (IDAPA 37.01.01.702) directs the Department to promptly issue a default order after expiration of the seven days for the party to file a petition contesting the default order.

**ORDER**

Thomas DeShazo and/or Castle Creek Ranch LLC are in default and their protest is **DISMISSED** and will not be further considered in the above captioned matter by the Department.
