- ii. The applicant shall submit plans and specifications along with estimated construction costs for the project works. The plans shall be definite enough to allow for determination of project impacts and implications.

The applicant shall seek comment and shall submit all letters of comment on the effects of the construction and operation of the proposed project from the governing body of the city and/or county and tribal reservation within which the point of diversion and place of use are located, the Idaho Department of Fish and Game, the Idaho Department of Environmental Quality, and any irrigation district or canal company within which the proposed project is located and from other entities as determined by the Director.

The Department of Water Resources ("Department") has received your application for permit to appropriate water and has accepted it for filing. Your application has been assigned the identification number referenced in the subject line of this letter. Please refer to that number in all future correspondence regarding this application.

Your application proposes to appropriate Trust Water as described in this letter. The special nature of the trust affects how the Department will process your application as well as some aspects of the water right that may result. The purpose of this letter is to inform you of three items specific to applications proposing to appropriate Trust Water:

- Your application will be subject to additional evaluation compared to applications that do
 not propose the use of Trust Water. This may require you to submit additional information
 and to demonstrate that your application meets the statutory evaluation criteria for
 appropriating Trust Water.
- 2. If a water right is issued to you, it could be subject to curtailment to satisfy senior minimum stream flow water rights on the Snake River at the Murphy Gage.
- 3. If a water right is issued to you, it will be subject to a periodic term review that may impact the future use of the right.

To understand better these three items and why they apply to your application, it helps to understand what Trust Water is and how it came about.

Trust Water arose from the 1984 Swan Falls Settlement between Idaho Power Company ("IPC") and the State of Idaho ("State"). ¹ Prior to the Swan Falls Settlement, the Idaho Supreme Court determined IPC held water rights for use at Swan Falls Dam that exceeded the entire flow of the Snake River at times. This limited future upstream development of water resources in the Snake River Basin. The Swan Falls Settlement resulted in changes to Idaho Law² and to IPC's water rights. As a result of the Swan Falls Settlement and subsequent legislation and court decrees, IPC's hydropower water rights in excess of the minimum flows at Murphy Gage are held in trust by the State. This change allows future development using water that would have previously

been delivered to satisfy IPC water rights at Swan Falls Dam and, therefore, would have been unavailable for upstream appropriation. The purpose of this trust is defined in Idaho Code § 42-203B as follows:

The purposes of the trust established by ... this section are to assure an adequate supply of water for all future beneficial uses and to clarify and protect the right of a user of water for power purposes ... to continue using the water pending approval of depletionary future beneficial uses.

Your application proposes a use of water that could deplete the rights placed in trust, so the State, through the Department must evaluate your proposal under the laws and rules that came after the Swan Falls Settlement. In addition to the usual statutory process and evaluation criteria, the Department must also evaluate whether your application will deplete Trust Water and, if so, whether your depletion of Trust Water is in the public interest.

In addition, the availability of Trust Water and the public's interest in the use of Trust Water could change over time. The Department will periodically review rights to use Trust Water to determine if Trust Water remains available for use and if the continued use of Trust Water is in the public interest. The periodic review will occur for any right that issues from your application. A future review by the Department could terminate or limit your ability to use the right in the future.

An important aspect of the Swan Falls Settlement is that the State agreed to protect the minimum stream flows in the Snake River at the Murphy Gage. Should the flows at the Murphy Gage fall below these minimums, the water rights that use Trust Water could be curtailed to restore flow to meet those minimums.

The Department will hold your application for 14 days to allow you time to contact us if you have further questions on this topic or if you choose to withdraw your application. If the Department does not hear from you within 14 days, the Department will process your application and prepare it for publication. If you choose to withdraw your application before it is submitted for publication, you will receive a full refund of your filing fee. Refunds are not available if an application is withdrawn after advertising.

Ryan,

We have received the applications and Jim and I have looked them over and had a couple of items we wanted clarified/addressed before we get too far into processing the applications...

It looks to us that each new application is for 7.4 cfs and the applications propose a combined limit of 7.4 cfs total. Each application proposes to divert up to this amount from June 2 – September 14. We were kind of curious where the 7.4 cfs number comes from. (The existing Rock Creek decree, 47-2116, allows for diversion of up to 10.0 cfs and the recent drain tunnel license, 47-8086, allows for diversion of up to 1.0 cfs, but Jim measured a diversion of 5.7 cfs of drain tunnel water last summer).

If the 7.4 cfs and 6/2 - 9/14 seasons are correct, then assuming the applications are approved Amalgamated Sugar Co would end up with the following allowed diversions for industrial &/or commercial uses...

Are we interpreting the two new applications correctly when combined with the existing rights/sources?

Both of the applications identify a place of use (item 9 on application) of the NWNE quarter-quarter and the NENW quarter-quarter of Section 26. However, both of the maps included with the applications only identify the NENW quarter-quarter as the place of use. The NENW quarter-quarter is what was licensed on the most recent license (47-8086) and appears to be the primary location of the sugar factory. We are not sure if there is actually non consumptive water use in the NWNE quarter- quarter.

• We need clarification on whether the application or the map identify the actual proposed place of use (which is correct).

Let us know if we are correct in our understating of the amount(s) of water and time periods being applied for, and which is the correct intended place of use. I am available at (208)736-3033 if you want to discuss any further.

Ryan,

As we discussed, IDWR recently issued license 47-8086 for diversion of 1.0 cfs of water from a drain tunnel for year round industrial use. The water right does not necessarily limit the right to consumptive or non-consumptive use. Condition #4 relates to how the right as a Trust Water right could be administered in the event that minimum stream flow rights in the Snake River at the Murphy Gage are not met. If a right is a Trust Water right, then one of two conditions is placed on the right....

When the minimum stream flow water rights in the Snake River at Murphy Gage are not being satisfied, the right holder shall cease diverting water for the consumptive uses authorized by this right. The minimum stream flow water rights are for 3,900 cfs from April 1 through October 31 and 5,600 cfs from November 1 through March 31. See IDAPA 37.03.08.030.

Or

Administration of this right to satisfy the minimum stream flow water rights in the Snake River at Murphy Gage shall not be required because use of water pursuant to this right is either non-consumptive or the right holder is required to provide ongoing mitigation to offset the depletion of water resulting from the use of this right.

The first condition (not used on 47-8086) indicates that the right will just be curtailed (shut off) and the second condition (the one used on 47-8086) indicates that it will not be curtailed (shut off).

As we also discussed, right 47-2116 (from Rock Creek) only allows for diversion from 9/15 to 6/01, so from 6/2 – 9/14 only right 47-8086 (from the Drain Tunnel) can be diverted. Right 47-8086 only allows for a diversion of 1.0 cfs (448.83 gallons per minute). Over a 24 hour period, this only provides 646,315 gallons of water. Data you provided indicates that from June 2 – September 14, diversions exceed this amount. It appears that Amalgamated Sugar may need to pursue another water source/right during this time of the year.
