The proof filed for 75-13977 was withdrawn and replaced with a Request for Extension. The fee for the proof should be transferred to the Request for Extension. And I believe a refund should be issued since the proof fee was \$100 and the Request for Extension fee is \$50.

Angie, based on my discussion with FC's local staff this morning:

Permit 75-14880 will be relinquished.

The Proof filed for 75-13977 in 2018 will be withdrawn, and a request for extension will be submitted prior to the original proof date in Feb, 2020. I believe there is good justification for the additional extension.

Formation Capital has undergone a change in entity name (not ownership) and is now known as Jervois Mining. The entity change documentation will be submitted with the relinquishment, and there should also be included an assignment of permit for 75-13977 and a change in ownership for 75-7073.

Jervois will re-evaluate their ground water needs and will likely file an additional application for permit in the near future.
