**DECLARATION OF CHERI MOORE IN
SUPPORT OF ECKHARDT FAMILY
LLLP'S MOTION FOR SUMMARY
JUDGMENT**

I, Cheri Moore, declare as follows:

1. I am over the age of eighteen (18) years and legally competent to make this declaration.

I have personal knowledge of the facts set forth herein, and I can testify as to the truth of the statements contained herein if called upon as a witness in this action.

2. I am a general partner of and the registered agent for Eckhardt Family LLLP ("Eckhardt").

3. I am familiar with Double C&J Land Co., Inc.'s ("Double C&J") completed application for water permit No. 67-15333 ("Application"), attached hereto as Exhibit A.

4. I am also familiar with the timely protest to the Application filed by Eckhardt on November 18, 2019, attached hereto as Exhibit B.

5. Double C&J has a limited easement to divert and store water from *Monroe Creek* in the Monroe Reservoir ("Easement"). But that Easement does not, and never has, authorized Double C&J to divert and store water from *Jenkins Creek* in the Monroe Reservoir. See Eckhart Expert Report, attached hereto as Exhibit C.

6. Although the Application seeks to divert water from Jenkins Creek to the Monroe Reservoir on a year-round basis, the Easement also has never authorized Double C&J to divert water into the Monroe Reservoir on a year-round basis. See Eckhardt Expert Rebuttal Report, attached hereto as Exhibit D; see also Water Right Report for Water Right No. 67-2044, attached hereto as Exhibit E.

7. Eckhardt will not provide Double C&J with a new easement to expand the current use of Monroe Reservoir on Eckhardt property. Double C&J has not requested, or otherwise approached Eckhardt about, such an easement.

8. In his original expert report, as well as his rebuttal to Eckhardt's expert report, Double C&J's expert failed to confront (or even acknowledge) the fact that the company's current easement does not permit Double C&J to divert and store Jenkins Creek water on Eckhardt's property. Attached hereto as Exhibits F and G are Double C&J's expert report and rebuttal expert report.







1. OVERVIEW

Double C & J Land Co ("Applicant") filed Application for Permit No. 67-15333 seeking to divert 345 afy from Jenkins Creek for Irrigation Storage, Irrigation from Storage, Stockwater Storage, and Stockwater from Storage. The Applicant describes the storage facility as an existing dam that has historically impounded water from Jenkins Creek and Monroe Creek.

Eckhardt Family LLLP (Eckhardt) filed a Notice of Protest against Application for Permit No. 67-15333 on the basis that diversions from Jenkins Creek have the potential to injure the ability of Eckhardt to put their downstream senior water right to use and that no authorization to use the Monroe Reservoir exists.

This report evaluates the Application's compliance with the requirements for approval set forth in Idaho Code § 42-203A(5). When reviewing Applications for Permit, the Director of the Department of Water Resources (IDWR) considers a number of criteria, including:

- (a) whether the Application will reduce the quantity of water under existing water rights, or
- (b) whether the water supply itself is insufficient for the purpose for which it is sought to be appropriated, or
- (c) whether it appears to the satisfaction of the director that such application is not made in good faith, is made for delay or speculative purposes, or
- (d) whether the applicant has not sufficient financial resources with which to complete the work involved therein, or
- (e) whether it will conflict with the local public interest as defined in section 42-202B, Idaho Code, or
- (f) whether it is contrary to conservation of water resources within the state of Idaho, or
- (g) whether it will adversely affect the local economy of the watershed or local area within which the source of water for the proposed use originates, in the case where the place of use is outside of the watershed or local area where the source of water originates.

As discussed below, the Application has the potential to reduce the quantity of water under existing water rights. Eckhardt has also raised concerns regarding speculation as Double C & J does not have authorization from Eckhardt (or BLM or Maddox) to store Jenkins Creek water at Monroe Reservoir.

2. APPLICATION FOR PERMIT 67-15333

2.1. Description of Application

Application for Permit 67-15333 (“Application”) was filed by Double C & J Land Co and received by IDWR on October 1, 2019. The original filing was incomplete and a complete application was filed on October 23, 2019. The application proposes a point of diversion at 12N 5W Section 6 NESW. The application proposes diverting a total of 345 afy with the following amounts, uses and season:

345 afy for Irrigation Storage from 1/1 to 12/31

345 afy for Irrigation from Storage from 3/1/to 11/15

345 afy for Stockwater Storage from 1/1 to 12/31

345 afy for Stockwater from Storage from 1/1 to 12/31

The diverting works are described as “Existing dam on Jenkins Creek that has historically impounded water from Jenkins Creek and Monroe Creek.” The reservoir is stated to have an active reservoir capacity of 345 af. Stock watering is described as 250 (the kind of livestock is not described). The application describes a place of use of 453 acres for irrigation from storage use with stockwater from storage use in the same location. The 453-acre place of use appears to correspond with other water rights owned by the Applicant for irrigation use including 67-2044, 67-2097A, 67-2097B, 67-4520, 67-14246, 67-14247, and 67-14251.

The application states that the point of diversion for the right is owned by the BLM and Eckhardt Family LLLP. Similarly, the storage facility known as Monroe Reservoir is not owned by the Applicant. The application’s narrative states:

“This application is filed in order to legally allow diversion of water from Jenkins Creek into Monroe Reservoir. Diversion of Jenkins Creek water into Monroe Reservoir has taken place for over 100 years, with the point of diversion claimed in the SRBA. On file with IDWR is a transfer to legally recognize the past 100 years of historic practice. No time is needed to complete the works as they are existing.”

2.2. Other Right Associated with Application’s Storage Facility

Application for Permit 67-15333 proposes diverting water from Jenkins Creek into storage on a year-round basis. The facility proposed to store water is located on Jenkins Creek is an existing dam and reservoir that is locally known as Monroe Reservoir. Decreed water right 67-2044, owned by Double C & J Land Co, authorizes the following uses:

6.4 cfs for Diversion to Storage from 11/15 to 03/15

320 afy for Irrigation Storage from 1/1 to 12/31

320 afy Irrigation from Storage from 3/15 to 11/15

The irrigation place of use for this right is the same 453 acres described by Application 67-15333. The point of diversion from Monroe Creek is located at 13N 06W Section 25 SENENE. Water right 67-2044 does not identify the location of the storage facility. No water rights owned by either the applicant or anyone else identifies the storage facility in NESW Section 6, T12N, R5W or diverting Jenkins Creek water into storage at that location.

The adjudication claim file for 67-2044 describes that water is diverted from Monroe Creek and conveyed through a ditch to Monroe Reservoir. Notes in the adjudication file indicate that the ditch from Monroe Creek to Jenkins Creek was not functional at the time of the adjudication. The claim, and subsequent decree, do not list Jenkins Creek as a source for storage.

3. ECKHARDT FAMILY LLLP RIGHTS

Eckhardt owns the following right associated with Jenkins Creek that stand to be injured by Double C & J's Application for Permit 67-15333.




Figure 1: Point of diversion and places of use for Double C & J application for permit 67-15333, and downstream points and place of use for Eckhardt right 67-11045.

Decreed water right 67-11045 with a June 27, 1934 priority date authorizes year-round diversion of 0.02 cfs from Jenkins Creek for instream stockwater use. The beginning and ending points of stream flow is 12N 5W Section 30 NENWNW (Lt 1). This right is located on Jenkins Creek downstream of the storage facility listed by the Application. The place of use for this right is depicted in Figure 1.

4. REDUCED FLOW (INJURY) ANALYSIS

The Application proposes diversion of water from Jenkins Creek into storage on a year-round basis. Storage releases will be used by the Applicant for irrigation and stockwater. The Application provides no provisions for releasing water to meet Eckhart's water right 67-11045, an in-stream stockwater right located downstream of the storage facility with a senior priority date to Application 67-15333. Eckhart water rights may be injured due to the reduced ability to use Jenkins Creek water unless sufficient flow is allowed to pass the dam to fulfill 67-11045.

5. GOOD FAITH / SPECULATION




Figure 2: Parcel Map Surrounding the Monroe Reservoir

Figure 2 shows a snippet of the Washington County Parcel Map, in which the three parcels forming a mosaic over the storage facility in the center of Section 6 T12N, R5W include:

- RP12N05W062400 – owned by Eckhardt Family, LLLP
- RP12N05W064200 – owned by BLM
- RP12N05W060000 – owned by Maddox Bar EX Ranch LTD PRTSHP

The Application identified the POD at the Monroe Reservoir, which is on land owned by others. One of the IDWR's criteria for approval will be a consideration whether the application is speculative. In this instance, the Application is made with the POD located on property the applicant does not own and no evidence that there is an agreement or authorization to store Jenkins Creek water with Eckhardt, BLM or Maddox.

6. SUMMARY AND CONCLUSIONS

Eckhardt protests Application for Permit 67-15333 on concerns that diversions from Jenkins Creek has the potential to affect the ability to fulfill their senior downstream water right and that the Applicant is storing water in a facility located on land owned by Eckhardt, BLM, and Maddox without authorization.

INTRODUCTION

This report is prepared in response to the Applicant's Expert Report for Application for Permit 67-15333 in the name of Double C&J Land Company dated April 27, 2020. This Expert Report is referred to as the "IWE Report" in this document.

OPINIONS AND ANALYSIS

The IWE Report provides the following opinions numbered 1 through 4. SPF's response follows each numbered opinion.

1. Given its physical setting, Monroe Creek Reservoir has always used Jenkins Creek as a source. The Monroe Creek source augments Jenkins Creek, as in many years Jenkins Creek is not adequate to fully fill the reservoir.

Response: Double C&J Land Co's decreed water right 67-2044 authorizes diversion from Monroe Creek for storage in Monroe Reservoir. This right does not describe Monroe Creek as an augmenting source for storage, but instead describes Monroe Creek as the only source. This right does not authorize the storage of water diverted from Jenkins Creek.

2. The fact that Jenkins Creek was not a designated source for the reservoir prior to now was an oversight and not intentional.

Response: The fact that Jenkins Creek was not a designated source may have been an oversight, but this oversight does not provide authorization to store water diverted from Jenkins Creek.

3. Application for Permit 67-15333 seeks to correct this oversight and will not change the historic operation of the reservoir, or the drainage, in any way.

Response: Application for Permit 67-15333 proposes to divert water from Jenkins Creek on a year-round basis. Decreed right 67-2044 authorizes diversion to storage from November 15 to March 15, from Monroe Creek only, and does not authorize diversion to storage between March 16 to November 14. Therefore, Application for Permit 67-15333 proposes to change the authorized operation by vastly increasing the time in which water can be diverted to storage, as well as the source of water to be stored.

4. Application for Permit 67-15333 meets the criteria established in Idaho Code § 42-203A(5) and IDAPA 37.03.08 for approval by the Department.

Application for Permit 67-15333 has the potential to injure Eckhardt's decreed right 67-11045 and therefore does not meet the criteria established in Idaho Code § 42-203A(5) or IDAPA 37.03.08.

The IWE report states that if this application is not approved "...the Double C & J Land Co.'s farming and ranching operation will be devastated." Double C & J Land Co. owns water right 67-2044 authorizing diversion of water from Monroe Creek for storage in Monroe Reservoir. Double C & J Land Co. also owns other water rights authorizing diversion from Jenkins Creek for irrigation including water rights 67-2097B, 67-2097A, and 67-14251, the latter two of which authorize diversion to storage in Jenkins Creek Reservoir. Double C & J Land Co. has operated without the proposed additional storage from Jenkins Creek since IDWR's enforcement letter ended this unauthorized practice. It seems apparent that denial of application for permit 67-15333 will not devastate Double C & J Land Co.'s farming and ranching operation.

LEGAL CRITERIA

Application for Permit 67-15333 fails to meet the criteria set forth in Idaho Code and Idaho Administrative Rules.

Idaho Code §42-203A(5)

- Subsection (a) – Reduce the Quantity of Water Under Existing Rights.
 - The application proposes diversion to storage from a new source in a longer season which stands to reduce the quantity of water available to Eckhardt's right 67-11045
- Subsection (b) – Water Supply is Insufficient.
 - The applicant has failed to demonstrate that the supply is sufficient to fill both application for permit 67-15333 and Eckhardt's right 67-11045.
- Subsection (c) – Application Made in Good Faith, not for Delay or Speculation.
 - The applicant has failed to demonstrate authorization to store water under the new application on land not owned by the applicant.
- Subsection (e) - Application will not Conflict with the Local Public Interest.
 - Depriving Eckhardt's use under their existing decreed water right is not in the local public interest.
- Subsection (f) – Application is Contrary to Conservation of State's water Resources.
 - Water not stored by the applicant will be available to downstream water right holders including Eckhardt.
- Subsection (g) – Application will Adversely Affect the Local Economy.
 - Depriving Eckhardt's use of water right 67-11045 will adversely affect the local economy.

IDAPA 37.03.08 Rule 45 Evaluation

- 45.01.a – Whether the Proposed use will Reduce the Quantity of water under Existing Water Rights.
 - The proposed use stands to reduce the quantity available under existing water right 67-11045.

- 45.01.c.i – Legal Access
 - The applicant has not demonstrated legal access to store water under application 67-15333 on land owned by Eckhardt and BLM.

SUMMARY

Application for Permit 67-15333 should be denied. If the application is approved, the permit and subsequent license should be conditioned to ensure that Eckhardt's water right 67-11045 is not injured due to a reduction in supply.

Opinions

1. Given its physical setting, Monroe Creek Reservoir has always used Jenkins Creek as a source. The Monroe Creek source augments Jenkins Creek, as in many years Jenkins Creek is not adequate to fully fill the reservoir.
2. The fact that Jenkins Creek was not a designated source for the reservoir prior to now was an oversight and not intentional.
3. Application for Permit 67-15333 seeks to correct this oversight and will not change the historic operation of the reservoir, or the drainage, in any way.
4. Application for Permit 67-15333 meets the criteria established in Idaho Code § 42-203A(5) and IDAPA 37.03.08 for approval by the Department.

Introduction

Application for Permit No. 67-15333 is unusual in that it does not propose any change to water diversions in Idaho – it only serves to document a use that has existed for over 100 years.

Unfortunately, the Snake River Basin Adjudication (SRBA) did not result in identifying Jenkins Creek as one of the sources of Monroe Reservoir. Recently the use of Jenkins Creek as a source of water for the reservoir was challenged, which was a surprise to the present owners and operators of the reservoir. As it appears that this discovery was too late for correction within the SRBA, the applicant is using the Application for Permit as the vehicle to correct this error.

Background Information

Double C & J Land Co.'s lands came out of the federal domain in 1890 with patents signed by President Harrison. Double C & J Land Co.'s predecessor, the Idaho Intermountain Institute, designed and built Monroe Reservoir. The Institute applied for permission for the project with Department of Interior in 1910. A water right permit for an onstream reservoir was approved by the State Engineer (predecessor of IDWR) on April 22, 1910, and an approval was granted by the Department of the Interior in February/March 1913. A map of the approval is dated March 8, 1913, showing the drainage in and around Monroe reservoir as within the scope of the project.

Based on the SRBA stockwater claims that were filed by Eckhardt's attorney, the earliest patent for an Eckhardt parcel is September 13, 1913, with the rest being patented in 1917, 1920, 1921, 1922, 1923, and 1927. Therefore, the actions taken to permit and build Monroe Reservoir pre-dated Eckhardt's lands coming out of the federal domain.

A water right license, No. 5983, was issued by IDWR on February 12, 1929, for diversion from Monroe Creek to Monroe Reservoir with a priority date of May 3, 1914. This licensed water right was subsequently issued number 67-2044 and was decreed in the Monroe Creek Water Right Adjudication in the case of *Monroe Creek Irrig. Dist. v. Dickerson et al.* (Washington County, January 4, 1979).

The "error" in not listing Jenkins Creek as a source for the onstream reservoir was attempted to be corrected by Double C & J Land Co.'s predecessor, Mainvil, in the SRBA when he filed a claim for 67-2044. The reason this can be deduced is in Remarks, line 14 to the SRBA claim, Mainvil lists the legal description of Jenkins Creek as the point of diversion. For reasons unknown, an additional claim was not filed for the Jenkins Creek source and this use of Jenkins Creek water which had been ongoing for about 100 years was left out of the SRBA.

By the time this error was discovered, the SRBA did not allow for the correction of this routine type of omission. Thus, the Double C & J Land Co. was left with the option of filing an application with IDWR to correct this technical error in their water rights. This is the only remedy now available under law. Importantly, nothing on the ground will change with permitting and licensing. The only thing that will change if a permit and license are not issued is the Double C & J Land Co.'s farming and ranching operation will be devastated.

Analysis

One question that has been asked relative to the water rights for Monroe Reservoir is why Jenkins Creek was never filed on, given its central role in the filling of the reservoir.




Figure 1. Monroe Reservoir was constructed on Jenkins Creek, per USGS topographic map.

As depicted in Figure 1 below, the reservoir was built on Jenkins Creek. This topographic depiction was verified by an onsite review by the author of this report on January 8, 2020.

A review of the original Application for Permit reveals the original plan was to construct a reservoir holding 5860 acre-feet, much greater than the 345 acre-feet the reservoir presently holds. As depicted in Figure 2, the proposal was to irrigate 3,650 acres with water stored by a 100 feet high dam, as compared to the existing 36.2 feet high dam for the irrigation of 453 acres as specified in the present application. The contribution of Jenkins Creek would have been minor relative to the original proposal – it has been much more significant for the as-built dam and irrigation system.

There are two other factors that perhaps contributed to the oversight to show Jenkins Creek as a source of Monroe Reservoir. First, there are two other reservoirs on Jenkins Creek for use by Double C & J Land Co. The Jenkins Creek filings for these two perhaps provided complacency that the water rights for the reservoirs had been properly claimed. Second, Double C & J Land Co. purchased the ranch shortly after the claims had been filed in the SRBA by their predecessors John and Grace Mainvil. The new owners trusted the previous long-term owners to fully file on all of their claims, and Mr. and Mrs. Mainvil inadvertently missed this one.

Another consideration is that some of Monroe Reservoir is located on land now owned by Eckhardt. This might give rise to a thought that Eckhardt has a color of ownership in the reservoir. On the contrary, Monroe Reservoir has clearly been owned by the applicant and its predecessors based on all known records. For example, the IDWR Safety of Dams records going back more than 30 years appear to be devoid of any mention of Eckhardt. All of the maintenance of the dam during that time appears to have been conducted by the applicant and its predecessors. Thus, unless evidence to the contrary is produced, it is clear that the applicant is the owner of Monroe Reservoir.

- 45.01.a – Whether the Proposed use will Reduce the Quantity of Water under Existing Water Rights.
 - Double C & J Land Co. and their predecessors have been diverting this water for 100 years.
- 45.01.b – Whether the Water Supply is Insufficient.
 - Same as above, the project has been in place for 100 years.
- 45.01.c – Whether the Application is made in Good Faith, not for Delay or Speculative Purposes – requires an analysis of the intention of the applicant with respect to the filing and the diligent pursuit of application requirements.
 - This application for permit process merely corrects the water rights for the applicant.
 - 45.01.c.i – Legal Access.
 - Applicant shall have legal access to the property necessary to construct and operate, has the authority to exercise eminent domain to obtain such access, or in the instance of a project diverting water across federal land, has filed all applications for a right of way.
 - The project has been in place for 100 years. Permission was given by the federal government after the base farm/ranch property came out of the federal domain and was patented in 1890. Interior gave permission in 1913 for the water project.
 - In addition, Double C & J Land Co. has a statutory easement found in Title 42 with the presence of all diversion works for 100 years.
 - Double C & J Land Co. is filing necessary paperwork with BLM for a right of way.
 - 45.01.c.ii – Any Other Permits Necessary.
 - None on the private side.
 - Potentially need a right of way from BLM because of some change in FLPMA.
 - 45.01.c.iii – No Obvious Impediments.
 - None, the project has been built and in place for 100 years.
- 45.01.d – Sufficient Financial Resources.
 - Not applicable because it has been built and been operating for 100 years.
- 45.01.e – Local Public Interest Conflict.
 - If corrections to the paper record are not made, Double C & J Land Co. property will lose value, negatively affecting the local economy.

Summary

Application for Permit No. 67-15333 merits approval and issuance as a permit.

**Expert Rebuttal Report for 67-15333

Introduction

This report provides a rebuttal of the information provided in the report in this matter by Scott King of SPF Water Engineering, LLC, dated May 1, 2020, whereby Mr. King identifies two concerns relative to the Double C & J Land Co. application.

1. The Application has the potential to reduce the quantity of water under existing water rights.
2. Eckhardt has concerns regarding speculation as Double C & J does not have authorization from Eckhardt (or BLM or Maddox) to store Jenkins Creek water at Monroe Reservoir.

As described below, neither of these concerns should prevent the issuance of Permit 67-15333.

Impact of 67-15333 on Existing Water Rights




Figure 1. Monroe Reservoir was constructed on Jenkins Creek, per USGS topographic map.

The diversion of Jenkins Creek by Monroe Creek Reservoir – a reservoir that has been on-stream for over 100 years and was constructed with permission from the federal government and state of Idaho – enables capture of water in the reservoir during periods when water is available. Given the upstream location of this reservoir in the Jenkins Creek drainage, and given the arid nature of land in this basin, this water is available primarily during spring runoff periods. It is helpful to review the USGS topographic map, identified as Figure 1 in the expert report in this matter provided by the author of this rebuttal report.

Note that upstream from (to the north of) the reservoir, Jenkins Creek is depicted as an intermittent stream and downstream it is depicted as a continually flowing stream. This is not uncommon for an upper drainage reservoir because high flows that would otherwise flow out of the basin unused in the spring during periods of peak runoff are captured and released during lower flow periods later in the year, reducing the flashiness of the stream and steadying the hydrograph.

This describes what happens with Monroe Reservoir. Instead of reducing the availability of stockwater in downstream reaches, the reservoir enhances water availability in the creek during periods of low flow when stockwater would be important.

Authorization to Store Water in Jenkins Creek Reservoir

As described in Mr. King's report, Double C & J Land Company is not presently the owner of the land that surrounds Monroe Creek Reservoir. Mr. King describes as follows:

The Application identified the POD at the Monroe Reservoir, which is on land owned by others. One of the IDWR's criteria for approval will be a consideration whether the application is speculative. In this instance, the Application is made with the POD located on property the applicant does not own and no evidence that there is an agreement or authorization to store Jenkins Creek water with Eckhardt, BLM or Maddox.

The Double C & J Land Company application is not speculative for the following reasons:

1. Monroe Creek Reservoir was constructed by a predecessor in interest to Double C & J Land Company, and title to the reservoir has been passed to Double C & J Land Company.
2. Lands adjacent to 19th century and early 20th century waterworks in Idaho rarely have written easements. Take for example the canals in the Treasure Valley. There are countless situations where private land includes canals which were constructed before the land was developed and for which easements are unrecorded. The user of the water facilities has developed a prescriptive or unrecorded easement regardless of language in the deed.

3. Throughout decades of records held by the U.S. Bureau of Land Management (BLM) and the Idaho Department of Water Resources the author of this report is not aware of a single reference to either Eckhardt or the BLM as the owner of Monroe Creek Reservoir. All known records show Double C & J Land Company as the owner of the reservoir.

The allegation that Double C & J Land Company does not have possessory interest in the dam and reservoir is without merit.

Summary

Application for Permit No. 67-15333 merits approval and issuance as a permit.
