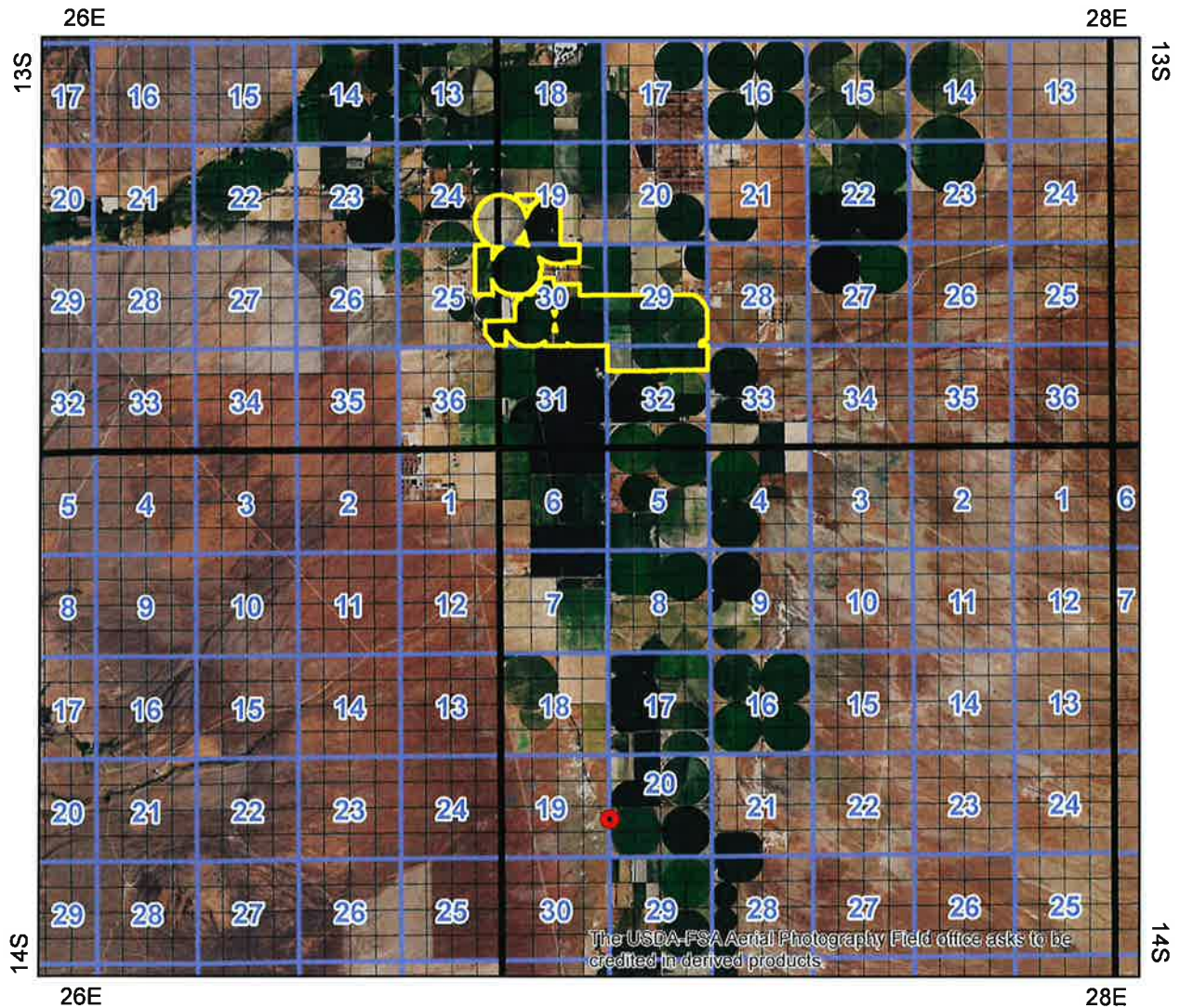

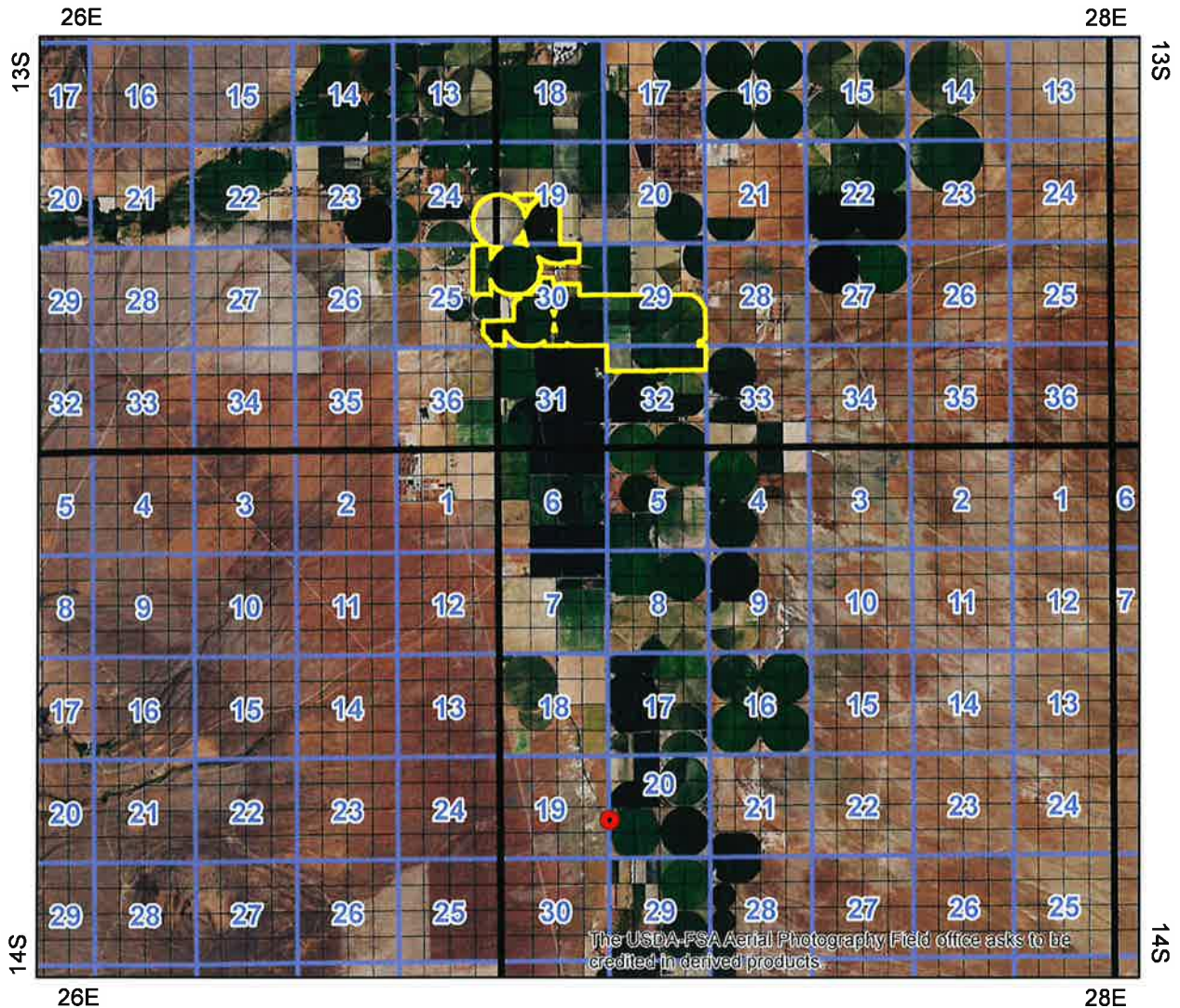

EXPLANATORY INFORMATION TO ACCOMPANY A PRELIMINARY ORDER

(To be used in connection with actions when a hearing was **not** held)

(Required by Rule of Procedure 730.02)

The accompanying order or approved document is a "**Preliminary Order**" issued by the department pursuant to section 67-5243, Idaho Code. **It can and will become a final order without further action of the Department of Water Resources ("department") unless a party petitions for reconsideration, files an exception and brief, or requests a hearing as further described below:**

PETITION FOR RECONSIDERATION

Any party may file a petition for reconsideration of a preliminary order with the department within fourteen (14) days of the service date of this order. **Note: the petition must be received by the department within this fourteen (14) day period.** The department will act on a petition for reconsideration within twenty-one (21) days of its receipt, or the petition will be considered denied by operation of law. See Section 67-5243(3) Idaho Code.

EXCEPTIONS AND BRIEFS

Within fourteen (14) days after: (a) the service date of a preliminary order, (b) the service date of a denial of a petition for reconsideration from this preliminary order, or (c) the failure within twenty-one (21) days to grant or deny a petition for reconsideration from this preliminary order, any party may in writing support or take exceptions to any part of a preliminary order and may file briefs in support of the party's position on any issue in the proceeding with the Director. Otherwise, this preliminary order will become a final order of the agency.

REQUEST FOR HEARING

Unless a right to a hearing before the Department or the Water Resource Board is otherwise provided by statute, any person aggrieved by any final decision, determination, order or action of the Director of the Department and who has not previously been afforded an opportunity for a hearing on the matter may request a hearing pursuant to section 42-1701A(3), Idaho Code. A written petition contesting the action of the Director and requesting a hearing shall be filed within fifteen (15) days after receipt of the denial or conditional approval.

ORAL ARGUMENT

If the Director grants a petition to review the preliminary order, the Director shall allow all parties an opportunity to file briefs in support of or taking exceptions to the preliminary order and may schedule oral argument in the matter before issuing a final order. If oral arguments are to be heard, the Director will within a reasonable time period notify each party of the place, date and hour for the argument of the case. Unless the Director orders otherwise, all oral arguments will be heard in Boise, Idaho.

CERTIFICATE OF SERVICE

All exceptions, briefs, requests for oral argument and any other matters filed with the Director in connection with the preliminary order shall be served on all other parties to the proceedings in accordance with IDAPA Rules 37.01.01302 and 37.01.01303 (Rules of Procedure 302 and 303).

FINAL ORDER

The Director will issue a final order within fifty-six (56) days of receipt of the written briefs, oral argument or response to briefs, whichever is later, unless waived by the parties or for good cause shown. The Director may remand the matter for further evidentiary hearings if further factual development of the record is necessary before issuing a final order. The department will serve a copy of the final order on all parties of record.

Section 67-5246(5), Idaho Code, provides as follows:

Unless a different date is stated in a final order, the order is effective fourteen (14) days after its service date if a party has not filed a petition for reconsideration. If a party has filed a petition for reconsideration with the agency head, the final order becomes effective when:

- (a) The petition for reconsideration is disposed of; or
- (b) The petition is deemed denied because the agency head did not dispose of the petition within twenty-one (21) days.

APPEAL OF FINAL ORDER TO DISTRICT COURT

Pursuant to sections 67-5270 and 67-5272, Idaho Code, if this preliminary order becomes final, any party aggrieved by the final order or orders previously issued in this case may appeal the final order and all previously issued orders in this case to district court by filing a petition in the district court of the county in which:

- i. A hearing was held,
- ii. The final agency action was taken,
- iii. The party seeking review of the order resides, or
- iv. The real property or personal property that was the subject of the agency action is located.

The appeal must be filed within twenty-eight (28) days of this preliminary order becoming final. See section 67-5273, Idaho Code. The filing of an appeal to district court does not itself stay the effectiveness or enforcement of the order under appeal.

Application for transfer proposes combining multiple places of use for 15 ground water rights and 12 Raft River rights to create a contiguous 1289 acre place of use (POU). The application also proposes adding all of the wells listed as points of diversion (PODs) on the 15 ground water rights plus 2 additional existing wells (10 wells total) as authorized points of diversion on all 15 ground water rights. The application also proposes adding an additional proposed POD to 8 of the Raft River rights. The 15 ground water rights and 12 Raft River rights allow for a combined total diversion of 24.23 cfs. The groundwater PODs, the Raft River PODs for 8 of the Raft River rights and the POU are located approximately 2.0 to 3.7 miles south and 0.5 to 2.8 miles east of Malta. The 4 remaining Raft River rights will continue to be diverted at a location approximately 8.0 miles south and 1.7 miles east of Malta.

There is a companion transfer (transfer #83746) to this application that requires concurrent processing. Both applicants "swapped" approximately 150 acres of irrigated lands and the wells associated with the swapped parcels while retaining ownership of the water rights appurtenant to the swapped acres to create contiguous POUs. These transfers seek to authorize the contiguous POUs and move the retained water rights to the swapped acres in each proposed POU.

Overlap analysis indicates there is no overlap with other irrigation water rights at the current and proposed POUs. All ground water PODs are located in Water District 143 and all surface water PODs are located in Water District 43C. Watermaster comments were solicited. The Watermaster of Water District 143 did not oppose approval of this application and the Watermaster for Water District 43C did not provide comments.

- **Authority to File:** IDWR records indicate the applicants currently owns all water rights and properties involved in the transfer.
- **Water Right Validity:** All water rights in the transfer were decreed in the SRBA on 6/28/2002. Recent aerial photography indicates that the properties associated with this transfer appear irrigated.

None anticipated.

None anticipated.

No issues anticipated.

Thank you for the opportunity to review the water right transfer application No. 83764 for changes to water rights from groundwater and Raft River in Cassia County.

IDFG's mission is to protect, preserve, and manage Idaho's fish and wildlife resources for the public interest (Idaho Code 36-103). Please consider IDFG's following technical comments/recommendations based on review of the attached application:

In terms of surface water resources, it is our understanding that the transfer proposes to add a point of diversion to eight Raft River water rights (43-171C, 43-178G, 43-254A, 43-287, 43-12926, 43-12927, 43-13075, 43-12928) at downstream locations (Section 24 Township 13S Range 26E and Section 25 Township 13S Range 26E). The change to a downstream diversion will result in some water benefits in the river reach between the existing and proposed point of diversion. Pump intakes should be screened with ¼" mesh or smaller to avoid entraining juvenile fish. Pumping should occur at a location within the creek away from potential fish refugia habitats (e.g., streambanks with overhanging vegetation, accumulations of woody debris, etc.).
