Mr. Hearing Officer,

In further response to your email, I have spoken with my client about this matter. Candice, Norm, and Fred,

I'd like to have a brief status conference by phone to discuss the hearing for Application 67-15333. If Idaho progresses through Governor Little's stages of reopening as hoped, the hearing will be during Stage Three. Yesterday Director Spackman issued a *COVID-19 2020 Return to Work Plan* ("Plan") describing how IDWR will function during each reopening stage. The Stage Three section of the Plan states, "In person, face-to-face meetings will be discouraged. Employees hosting meetings should

schedule teleconferencing. In-person meetings of 10 people or less are permissible in IDWR conference rooms if a six foot separation between participants can be maintained." The Plan also states, "The document will be amended as Idaho rebounds through each of the four stages." Therefore, it's possible that the Stage Three meeting guidance in the Plan could change.

The item I want to discuss with you is when and how your clients want to conduct the hearing. I see our options as follows:

- 1. Hold the hearing on June 11, 2020, as scheduled. Limit participation, or at least the number of room occupants, to 10 people. The conference rooms are big enough that 10 people can accomplish the recommended physical distancing fairly easily. I was hoping to involve three IDWR staff members, including myself, but I could limit our participation to two, if necessary.
- 2. Postpone the hearing until Stage Four or beyond. The Plan's Stage Four guidance allows for meetings of 1-50 people "if a six foot separation between participants can be maintained." The conference rooms we have reserved could probably be configured to accomplish the recommended physical distancing fairly easily for about 15 people.
- 3. Hold the hearing by telephone. I've not managed an entire hearing by telephone before, but I'm willing to try. An advantage of this option is that it is not dependent on Idaho's progression to Stage Three. One challenge might be ensuring the quality of the audio recording. Another might my ability to manage the flow of communication when more than one person wants to speak. I'm confident we can overcome those challenges.
- 4. A hybrid process where some participants, probably witnesses, are on the phone while some of us are in the hearing room. I've done this once before. In that case, one of the witnesses testified by telephone, and the recording was audible.
- 5. Wait until early in June to decide.

Going into the discussion, my preference will be #2 -- postpone the hearing until we can gather in one room and conduct the process more-or-less as we've conducted hearings in the past. It presents the fewest technical and procedural challenges and is consistent with the Governor's direction to limit gatherings of people.

My second preference will be #4 – having some of the participants join us by phone. Having the attorneys in the room and witnesses on the phone will limit the gathering while allowing me to manage the flow of communication.

My suggested times for a status conference are:

- 1. May 21, 2020, at 10:00 am.
- 2. May 21, 2020, at 3:00 pm.
- 3. May 22, 2020, at 10:30 am.

Please email me by the end of business on May 18, 2020, to let me know what time or times work best for you. If your client already prefers one of the options listed above, please include the preference in your response.
