Mr. Funsten,

The Department of Water Resources (Department) acknowledges receipt of your Notice of Change in Water Right Ownership (Notice).

Our review of your Notice indicates that additional information may be required before the Department could process the change.

73-12264 and 73-12265 were in the Water Permit stage, which regularly requires an Assignment of Permit. Notice of Statement of Completion Due, the process in which to prove the use of the water permit, was sent to James and Karen Posada on October 31<sup>st</sup>, 2019. The Statement of Completion was due to the Department on January 1<sup>st</sup>, 2020. On January 6<sup>th</sup>, 2020 a Lapse Notice was sent to James and Karen Posada due to no written response received by the Department. As of the date of the Lapse Notice, Water Permit 73-12264 and 73-12265 are considered Lapsed and no longer valid under the provisions of Idaho Code § 42-218A.

#### At this time, you have options:

- With the documentation provided in the Quick Claim Deed specifying Water Rights 73-182, 73-12264 and 73-12265 to be included in the sale of the property the Department may move forward in the processing of the Notice, rather than requiring an Assignment of Permit. By completing the Ownership Change on 73-182, 73-12264, and 73-12265, you could move forward and being the process to reinstate the lapsed water permits as outlined in Idaho Code § 42-218A.
- The Department only process the Ownership Change of Water Right 73-182, and issue Blaine County Title a refund of \$50.00.
