**ORDER WITHDRAWING
MAY 1, 2020 PRELIMINARY ORDER
AND TRANSFER APPROVAL**

On May 1, 2020, the hearing officer for the above-referenced contested case issued a *Preliminary Order Approving Transfer and Transfer Approval 81800*. The hearing officer was notified that the Transfer Approval 81800 contained clerical errors. Pursuant to Rule 760 of the Department's Rules of Procedure (IDAPA 37.01.01), a hearing officer may modify an order within 14 days of the issuance of the order. This is accomplished by withdrawing the original order and issuing a substitute (or amended) order. The Department should issue transfer approvals that accurately describe the water rights involved in a transfer application. The hearing officer has determined that the clerical errors identified in the original order should be corrected. Therefore, the *Preliminary Order Approving Transfer and Transfer Approval 81800* issued on May 1, 2020 should be withdrawn.

ORDER

IT IS HEREBY ORDERED that the *Preliminary Order Approving Transfer and Transfer Approval 81800* issued on May 1, 2020 are WITHDRAWN. An *Amended Preliminary Order Approving Transfer and Amended Transfer Approval 81800* have been issued in conjunction with this order.
