

The right holder shall be responsible for monitoring the daily flow of the Clearwater River using real-time data and shall cease diverting water when flows in the Clearwater River are below established minimum flow amounts. Unless otherwise specified by the Director of the Department of Water Resources, data from the U.S. Geological Survey Spalding gaging station, No. 13342500, may be used for purposes of determining the daily flow amounts.
- 13. Prior to the diversion and use of water under this approval, the right holder shall comply with all fish screening and/or fish passage requirements of the Idaho Department of Fish and Game.

**Applicant:** Temporary Application 85-53 from Knife River Corporation was received in the State office on 4/6/2020. The application proposes to divert water from the Clearwater River in Nez Perce County for construction operations at the Big Eddy Recreation Site and launch area. This site is located on Dworshak Reservoir in the NE Q of Sec. 27 Twp. 37N Rge.01E and the NW Q of Sec. 26 Twp. 37N Rge. 01E. The point of diversion (POD) requested is located roughly 15 miles downstream from the outlet of the reservoir. It appears this temporary approval is a renewal of a prior application (85-48) approved by Northern Region in 2017. (The map included with the application had 85-48 written at the top and a Northern received stamp of 2/27/2017).

The application states that the POD and place of use (POU) are owned by the State of Idaho and that Knife River is contracted with Idaho Transportation Department (ITD) and permitted to use the land.

**Proper Administration:** There is no current water district for the area and no administrative issue are apparent.

Public Interest: Based on the information available, the proposed use is within the public interest.

**Injury to Public Values:** Based on the information available, the proposed use would not injure public values. Comments were requested from the Idaho Fish and Game (IDFG), Department of Environmental Quality (DEQ) and the Water Resource Board (Board) on 4/8/2020. No response was received from the DEQ or Board within 14 days so it was presumed that they had no concerns. IDFG responded on 4/9/2020 recommending the pump intake have a maximum the pump intake have a maximum screen mesh size of 3/32- inches and also the approach velocities at the intake should not exceed 0.5 feet per second.


**Other Sources of Water:** There are no other sources of water in the immediate proximity to the requested point of diversion. It is reasonable for the applicant to request to divert from the Clearwater River.

**Injury to Existing Water Rights**: The application proposes diverting .13 cfs (60 gpm), a maximum daily volume of .11 AF and 4.4 AF over the duration of the request. The closest downstream POD is approximately 2.3 miles for right 85-7438. This right authorizes the diversion of 0.01 cfs for the irrigation of 0.5 acres. Injury to this right does not seem apparent based on the diversion rate and minimal acreage that is irrigated.

Minimum Stream Flow (MSF) rights 86-7318 and 86-7345 exist on the Clearwater River to protect fish and wildlife habitat, aquatic life and recreational uses. Right 86-7318 exists along the proposed POD on the Clearwater River while right 86-7345 is below the proposed POD, closer to Lewiston, Idaho. The MSF for right 86-7318 requires 4,350 cfs from 8/1 to 1031 and 5,750 cfs from 11/1 to 7/31. The closest USGS Streamflow Gage # 13342500 (Clearwater River at Spalding, ID) is approximately 15.5 miles downstream from the proposed POD. Using the historic data collected from this gaging station, I calculated the mean flow for each month from 47 years of flow data. The table below summarizes the mean flows for the months of May-October that Knife River proposes diverting compared to the MSF levels for 86-7318.

Month	May	June	July	August	September	October
Average Flow(cfs)	36,000	30,800	14,800	9,230	6,740	4,040
MSF Level (cfs)	5,750	5,750	5,750	4,350	4,350	4,350

Based on the average monthly flows, the only month the MSF would not be met is October. The difference in the MSF and average October flow is 310 cfs and Knife River only requests to divert from the Clearwater until October 15. Furthermore, the current Snow Water Equivalent (SWE) for the Clearwater River Basin is at 116% of average which should help maintain the MSF levels of right 86-7318 in 2020 (a map of current SWE is below). Based on these factors, injury to 86-7318 does not seem apparent.



For MSF right 86-7345, 5,910 cfs is required from 11/01 to 7/31 and 4,498 cfs is required from 08/01 to 10/31. Unfortunately, USGS gaging station # 13343000 (Clearwater River near Lewiston, ID) did not have any current or historical streamflow data available. However, based on the current SWE levels in the Clearwater Basin and the proposed use, injury to 86-7345 does not seem apparent. Conditions will be

added to the temporary approval of water use to limit diversions to those times that enough water is available to satisfy MSF rights 86-7318 and 86-7345.

**Department Staff and Watermaster Comments:** Comments were submitted to Northern Region on 4/8/2020 and a response was received the next day. Northern requested adding a condition to the approval regarding the minimum stream flows on the Clearwater River. The condition asserts that the applicant will be responsible for monitoring the daily flows at the Spalding, ID USGS gaging site and shall not divert when the MSF's are not being met.
