



Idaho Falls Farms LLC recently purchased three farms and it is necessary to update the irrigation POUs for the three farms. Idaho Falls Farms LLC has previously submitted to IDWR ownership and water right split forms to be processed with the attached transfers. Warranty deeds and the ownership change forms have already been submitted to IDWR.

No beneficial use change, period of use change or POD changes are proposed with the attached three transfers. No ESPA Model analysis was performed for these transfers.

The 1st transfer is for water rights 35-14165, 35-14167, 35-14169, 35-14171 and 35-14173. After this transfer is approved and the water rights splits previously submitted to IDWR are processed, these water rights will be able to irrigate 1570.0 acres.
