

- 12. Prior to the diversion and use of water under this approval, the right holder shall comply with all fish screening and/or fish passage requirements of the Idaho Department of Fish and Game.
- 13. A fish screen of 3/32-inches or smaller mesh shall be installed and maintained at the point of diversion.
- 14. The approach velocity at the point of diversion shall not exceed 0.5 feet per second.
- 15. Water shall not be diverted under this right when flows in the Clearwater River are below minimum flow amounts as defined by Right 86-7345. The right holder shall be responsible for monitoring the daily flow of the Clearwater River using real-time data and shall cease diverting water when flows in the Clearwater River are below established minimum flow amounts. Unless otherwise specified by the Director of the Department of Water Resources, data from the U.S. Geological Survey Spalding, ID gaging station, No. 13342500, may be used for purposes of determining the daily flow amounts.

## MEMORANDUM

**Date:** April 17, 2020

To: Temporary Application For Water Use Review

**Re:** Temporary Water Use Application TP-86-72

Applicant: The State Office received a temporary approval on 4/6/2020. The application proposes to divert water from the Clearwater River at Turkey Island and Hog Island for construction operations. These islands are located on the Clearwater River just East of Lewiston, Idaho. The PLSS descriptions on the application for the points of diversion (POD's) did not match the map included. The application was signed by Kalob Turner. I called him on 4/7/2020 in order to clarify the POD locations. After our conversation, he sent me an email with a clearer image showing the Turkey and Hog Islands. The POD associated with Turkey Island is located in the NWNE QQ of Sec. 13 Twp. 36N Rge. 04W and the Hog Island POD is located in the NESE QQ Sec. 20 Twp. 36N Rge. 04W.

This proposal appears to be a renewal of a previous temporary application (86-57) that was approved by the Department in 2017. (The application map had 86-57 and a received stamp from Northern Region on 2/27/2017).

The application states that the POD and place of use (POU) are owned by the State of Idaho and that Knife River is contracted with Idaho Transportation Department (ITD) and permitted to use the land.

**Proper Administration:** The proposed POD's and area of water use are not within a current water district. There appears to be no administrative issues within the proposed area and thus proper administration is likely not an issue. There is a strong likelihood of adequate water supply for the requested use. Reference the discussion under the injury to existing water rights section below.

Public Interest: Based on the information available, the proposed use is within the public interest.


Injury to Public Values: Based on the information available, the proposed use is does not appear to injure public values. On 4/9/2020, comments were requested from the Idaho Fish and Game (IDFG), Department of Environmental Quality (DEQ) and the Water Resource Board (Board). If no response was received within 14 days, it was presumed that the agency or group did not have concerns. The IDFG responded the same day recommending the pump intake have a maximum screen mesh size of 3/32-inches and also that the approach velocities at the intake should not exceed 0.52 feet per second.

**Other Sources of Water:** There are no alternate sources of water nearby so it is reasonable to request to divert from the Clearwater River.

**Injury to Existing Water Rights**: The application proposes diverting .13 cfs (60 gpm), a maximum daily volume of .11 AF and 4.4 AF over the duration of the request. The amounts requested will be divided

between the two locations. There are multiple water rights diverting water from the Clearwater River below the POD's at Turkey Island and Hog Island. Furthermore, Minimum Stream Flow (MSF) right 86-7345 exists on the Clearwater River along the locations of the request POD's.

USGS streamflow gage #13343000 (Clearwater River near Lewiston, ID) is located below the proposed POD's. However, the gage does not have current or historical flow data available. Fortunately, USGS gage 13342500 (Clearwater River near Spalding, ID) is located between the POD's. This gaging stating will provide the best information to judge flows in the Clearwater River. Using the historical flow data from the last 47 years at this station, MSF levels would be met each month of the duration of the request except for October. The proposal only extends until October 15<sup>th</sup> and current Snow Water Equivalent (SWE) levels in the Clearwater Basin are at 116% of average snowpack. Below is a map of current the SWE in Idaho as well as the average flows from the Spalding, ID USGS gave compared to the required MSF levels for 86-7345:

Based on the information available, the proposed use would not injure MFS right 86-7345 or other existing water rights.

**Department Staff and Watermaster Comments:** There is no water district for the area and therefore no watermaster. Comments were requested from Northern Region on 4/9/2020 and a response was received the same day. Northern requested that a condition be added to the proposal ensuring that MSF levels are being met downstream on the Clearwater River.


