Dear Ms. Little:

As you may be aware the State of Idaho, Department of Water Resources has been working on the Snake River Basin Adjudication for the past several years. Currently they are working on the Boise River.

In an effort to record water usage accurately in the Boise basin we are requiring all diversions to install or update their measuring devices. Currently the Meeves Ditch/Pump has no way to measure usage according to State law.

This letter is to advise you that we will require a way to accurately measure your usage beginning with the 2010 water season.

There are several ways to meet this requirement. If you will contact me at the Water District #63 office, I will set a time to meet with you at the site of your diversion to discuss your options.
