

Dear Interested Parties:

The Department of Water Resources (Western) acknowledges receipt of your Notice of Change in Water Right Ownership. Our review of your Notice indicates that additional information is required before the Department can process the change. The information required is indicated below:



One fee of \$25 was submitted with your Notice, which is sufficient for one of the two water rights listed. An additional fee of \$25 is required to process the second water right. Additionally, the warranty deed submitted is not signed or notarized. The Department requires a signed and notarized copy of the warranty deed in order to process a change in ownership.

However, before submitting an additional fee and paperwork, please note the following:

During our review of the documentation you submitted we found discrepancies between that documentation and the legal description of the place of use for the water rights indicated in your notice. I have enclosed a copy of the water rights and annotated map for your reference.

If you do own the property referred to in the legal description of the water rights, please submit evidence of your ownership of that property to the Department. If you do not own the property, please submit a new form for any water rights that do apply to your property, or a letter withdrawing your Notice.

Because the Department cannot process the Notice without proper documentation and fees, we will hold any action on your notice pending receipt of the necessary information and fees. If we do not receive the necessary information and fees within 30 days (April 5, 2020) we will return your notice and all attachments/fees and your notice will not be processed.

Also, please note that permit holders are required to report any change of ownership and/or mailing address to the Department within 120 days of the change. Failure to report these changes could result in a \$100 late filing fee. Forms to assign ownership or update your address are available from any office of the Department or on the Department's website.
