Hello Shirley,

We spoke earlier today about the Resumption of Use Notices for water rights 37-21856, 37-21873, 37-21890, 37-21907, & 37-21924. Over the phone you said that you are working towards resuming use of these rights, but you are concerned that you will not be able to resume full use of your water rights before the April 27, 2020 resumption of use date. Your concerns include that your resumption of use of the water rights depends in part on getting assistance to resume use of the diverting works. Getting that assistance is being delayed due to safety precautions being taken for the COVID-19 virus.

In order to get assistance with your resumption of use, I am including the contact information for your water district (WD 37). Contact the district to inform the watermaster that you will be resuming your water use this season.

We also discussed that with the irrigation season in your region beginning on April 15, it is possible that water may not be available for full use by April 27. With respect to the resumption of use date, if I were in your position I would write "The 2020 irrigation season" as my entry on the form for "Show the date water use was resumed under this water right"

The owner of record for these rights is Shirley Barer, and it is your signature that is expected on the resumption of use form.

Your combined water rights authorize the irrigation of 5 acres.

The rates for each water right are listed below, but I would write in the Total rate = 0.27 cfs

37-21856 - 0.08 cfs
37-21873 - 0.005 cfs
37-21890 - 0.05 cfs
37-21907 - 0.005 cfs
37-21924 - 0.13 cfs
Sum total = 0.27 cfs
