In order for an address to change on a water right the *owner must submit the current address, signed and in writing* to the Department. Our office will send confirmation that the change has been completed.

Please note that Section 42-248, Idaho Code, requires you or the owner of this water right to maintain current ownership and address records on file with the department.
