As you may know, we belong to a family of businesses with a shared mission: to decrease the pressure on wild salmon and trout. Originally, each business was named independently: Spring Salmon (parent company), Riverence (salmon and trout egg production in Washington), and Evaqua Farms (trout production and processing in Idaho). Though each business provides unique value to different industry sectors, the naming structure makes it challenging to tell our shared story and mission.

I'm pleased to announce that as of January 1, 2020, all of our businesses now share the Riverence name. **Evaqua Farms LLC has been renamed to Riverence Farms LLC**, Riverence (our egg farm in Washington) has been renamed to *Riverence Brood LLC*, and the parent company of our operations is *Riverence Holdings LLC*. Implementing the Riverence naming convention throughout our organization will help promote market recognition for every aspect of our business, and will help our customers communicate the value of our products from egg to plate.

It's important to note that these are name changes only: each business has the same leadership, same mission, same products, and same staff.
