OTHER BUSINESS : THE WEIR AT SAGE HEN DISCUSSED. MR. LESTER OF WATER RESOURCE BOARD, SUGGESTED THE WATER BE CALIBRATED AT DIFFERENT FLOW PERIODS AND MEASURE MARKS BE MADE TO ALLOW THE WATERMASTER TO CHECK FLOW AT A GLANCE ACCORDING TO MARKS. VAUGHN SPIKER APPOINTED TO GET CALIBRATIONS DONE.

RAISING THE SIDES OF THE WEIR WAS DISCUSSED BUT DECIDED TO GO WITH THE CALIBRATION THEORY.
