The Annual meeting of Water District 65-A was held Monday March 3, 1997 at Ola, Idaho.

The meeting was called to order by Chairman Harry McCaulou.

Nominations were made and seconded that officers remain the same as 1996.

Minutes read and approved.

A credential committee was appointed as follows: Vaughn Spiker, Eric Herr, and Homer Nesbitt. The committee voted to vote one vote per water user.

Eric Herr accepted the Water Master job for 1997 water year.

Eric Her made the motion to set the budget the same as 1996. The budget was Water Master wage of 506.00, Secretary \$40.00 Workmans Comp. and Misc. \$402.00, for a total of \$948.00.

Motion was seconded by Vaughn Spiker.

Vaughn Spiker also suggested that a resolution be sent to the County for the budget be collected through the tax roll.

Vaughn Spiker made a motion and Homer Nesbitt seconded that the advisory committee remain the same as 1996.: Kirk Darnell, Vaughn Spiker, and Don Skippen.

Homer Nesbitt ask is dam at Sage was of need of repair? Discussion followed. Inspection of the pipe at Sage Hen was discussed.. Eric Herr reported that the steel needed some repair , a resin coating would work but the pipe needed to be completely dry to apply.

Secretary Janice ask to whom she should refer Title Co. when property was being sold and the question of water rights came up in Ola. Steve Lester reported the Water resource Board should have all property with water rights on file .
