During our phone conversation we spoke about your portions of the water Wargi rights and where they are diverted. Our records identify the old pump on Dave Renberg's land as the diversion point for those water rights. If diversion has been made elsewhere then it is unauthorized and you are directed to stop using it until you file for a transfer to change the point of diversion and it is approved.
