The Department of Water Resources acknowledges receipt of your Notice of Change in Water Right Ownership.

It appears we have sufficient evidence of ownership and fees to complete 21-13146 however our review of your notice indicates that additional information is required before we can process the change for 21-13145. The information required is indicated below:

**** **Evidence of Water Right Ownership:** We need a chain of deeds from Thomas Williams to the following for the following parcels: Douglas Williams (parcel 1 and 1A), Bonnie Lou Thompson (parcel 3 and 3A), Nancy Kay Stewart (parcel 4 and 4A), Marjorie Karen (parcel 5 and 5A), Wendy Clark (parcel 6 and 6A) and Shannon Ostler (parcel 7 and 7A)

ALSO

**** **Split Fee:** Also it appears 21-13145 will require a split please review the map attached if you believe you own the entire place of use, please submit evidence of ownership for the entire place of the water right, particularly the portion in NESW Government Lot 12. If you believe a split should be complete please submit an additional \$75.00. The fee for a split is \$100.00 per water right, you have already paid \$25.00 (for 21-13145) therefore an additional \$75.00 is required.

Because the Department cannot process the ownership change without proper documentation/fees, we will hold any action on your notice pending receipt of the necessary information/fees. If we do not receive the necessary information/fees within 30 days we will return your notice and all attachments and your notice will not be processed.

Please note that Section 42-248, Idaho Code, requires you or the owner of this water right to maintain current ownership and address records on file with the department. Forms to file a change of ownership of a water right and/or a change in the address of the water right owner are available from any department office, or at the department's website at: www.idwr.idaho.gov.

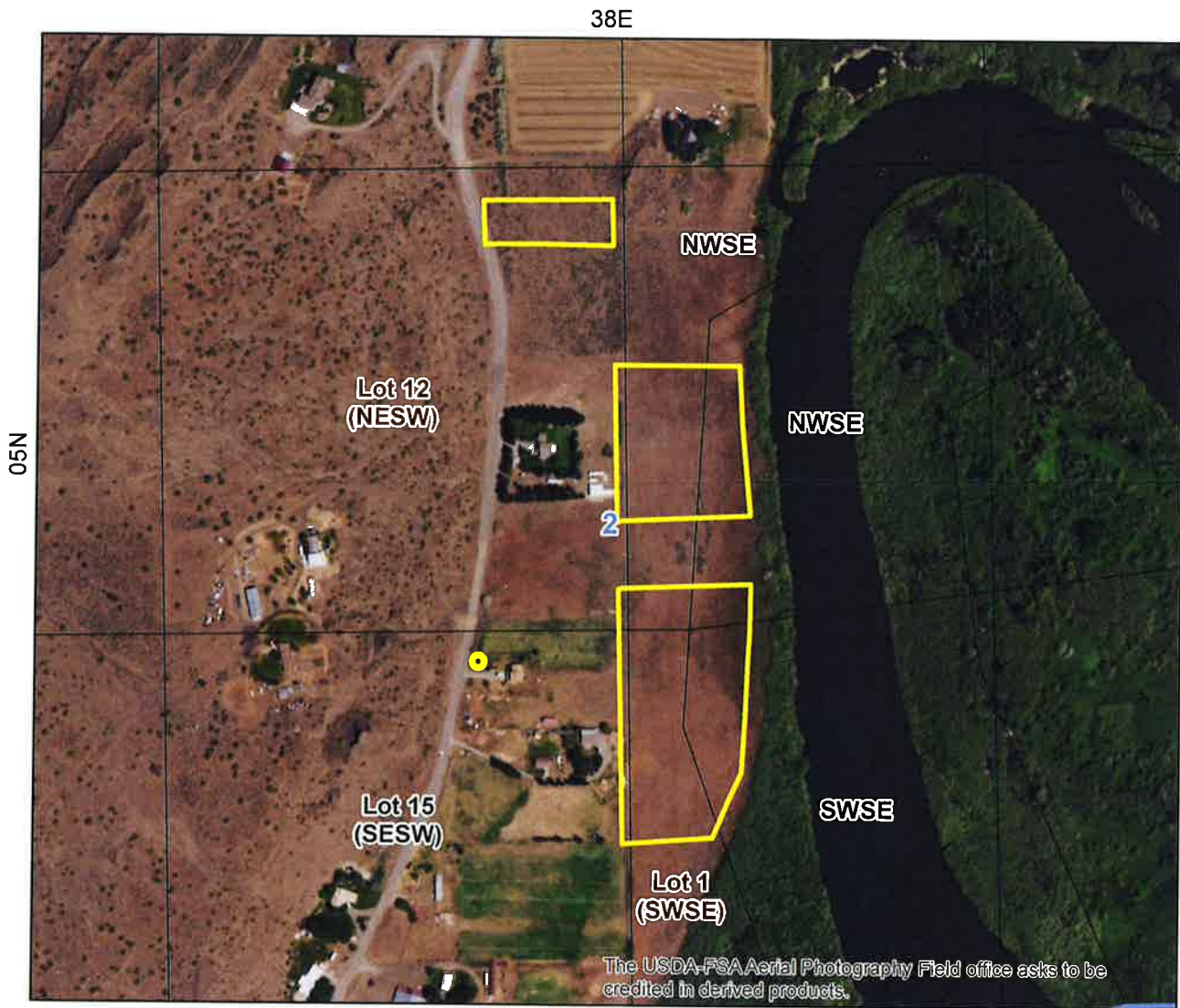
