Dear Applicant:

This letter is meant to notify you that Application for Temporary Approval of Water Use TP-34-26 has been denied. Water District 34 currently holds two water right permits which, in combination, authorize up to 800 cfs of ground water recharge at various locations in Basin 34. Both of these existing permits were, prior to their approval, contested applications before the Department. The contested cases were ultimately resolved without an administrative hearing. Both permits refer to a Settlement Agreement and Stipulation dated April 21, 1997 and a Plan of Operation, which governs recharge activities in Basin 34. The ground water recharge use proposed in Application TP-34-26 is not consistent with the current Plan of Operation for Basin 34. Because the proposed recharge use was a departure from the historical recharge activities occurring under the two existing permits, the Department felt it was necessary to provide notice of Application TP-34-26 to the parties to the original contested cases.

On January 17, 2020, the Department sent notice of Application TP-34-26 to thirteen entities or individuals. The notice advised the recipients to provide comments to the Department on or before February 18, 2020 if they were opposed to the recharge use proposed in Application TP-34-26. Of the thirteen entities or individuals receiving the notice, only four provided comments to the Department. In addition, the Department received comments from other individuals who were not involved in the original contested cases for the two existing permits. A summary of the comments is enclosed.

Idaho Code § 42-202A governs the application for and review of temporary approvals and states that the Department may deny a temporary approval if the Department determines that the proposed use would "injure public values associated with the water source or any other water right." The comments provided to the Department show that there are public interest concerns related to the proposed recharge use. In addition, as of today, the snowpack for Basin 34 is only 62 percent of normal. Therefore, the flow in the Big Lost River will likely be below average this year, meaning the non-irrigation season might be the only time there is flow in the Big Lost River channel between Moore and Arco. Ideally, Water District 34 would amend its Plan of Operation to allow for the proposed recharge use under its existing recharge rights, while still addressing the concerns of people in the lower valley. Amending the Plan of Operation may take some coordination with the parties to the previous contested cases, particularly those who provided comments about Application TP-34-26. The Department encourages Water District 34 to contact the individuals and entities providing comments and discuss a possible amendment of the Plan of Operation. Please contact me if you would like a representative from the Department to participate in those discussions.

Big Lost River Water Users Association is apposed to Winter Recharge on the Big Lost unless there is River flows to the Huggins/Braswell bridge. In recent years higher than normal snowpack has helped in recharging the lower Valley. However, even with higher snow pack and the River flowing during certain times and months, not all water rights have been restored. Several Spring rights with earlier priority than ground water diversions are still suffering for a lack of flows in the River above and below Arco. Big Lost River Recharge Settlement Agreement and Stipulation states that the purpose is to "hydrologically and broadly benefiting all residents and interests in the Valley". A study was conducted last year by INL and The Department of Water Resources. We are unaware of the results and findings of this study. Until that study or additional studies support sinking water in Custer County will benefit the situation above and below Arco we oppose this Winter Recharge.

Notice of Application for Temporary Approval of Water Use TP-34-26 in the Name of Water District 34

On December 16, 2019, Water District 34 filed Application for Temporary Approval of Water Use TP-34-26, proposing to divert a total of 40 cfs from the Big Lost River at two locations in Section 14, T06N, R25E for ground water recharge. A copy of Application TP-34-26 is enclosed with this notice.

Water District 34 currently holds Permits 34-7571 and 34-7573 which, in combination, authorize the diversion of 800 cfs from the Big Lost River and some of its tributaries for ground water recharge at various locations throughout the Big Lost River basin. The Department issued Permits 34-7571 and 34-7573 in 1998 after protests against the underlying applications were withdrawn. Some of the protests were withdrawn without condition. Others were withdrawn through an Agreement (dated June 5, 1995). Still others were withdrawn through a Settlement Agreement and Stipulation (dated April 21, 1997). A copy of the 1995 Agreement and the 1997 Settlement Agreement and Stipulation are enclosed with this notice. The entire files for Permits 34-7571 and 34-7573 are available online at:

Both of the permits include the following condition of approval:

Approval of this right is subject to the Plan of Operation and Agreement and Stipulation dated April 21, 1997.

Water District 34 adopted a Recharge Plan of Operation in April 1997 which contains the following provision:

For the Big Lost River itself downstream from Mackay Dam, diversion for recharge downstream from Mackay Dam will not occur unless the flow at the Arco gage is 60 cfs or more measured as a three consecutive day average. The 60 cfs at the Arco gage is for purposes of this Plan of Operation only and is not and cannot be construed as a minimum flow or minimum flow water right under any theory of law.

Application for Temporary Approval of Water Use TP-34-26 does not propose to be subject to the 1997 Recharge Plan of Operation or its requirement that diversion nfor ground water recharge not occur unless 60 cfs of water is flowing in the Big Lost River at the Arco gage.

Idaho Code § 42-202A states that the Department is not required to publish notice of an application for temporary approval of water use, but may provide notice of such an application as the Department deems appropriate. The Department has determined that all of the protestants to Applications 34-7571 and 34-7573 should be notified of the current recharge proposal. You are receiving this notice because you were a protestant to Application 34-7573.

Idaho Code § 42-202A governs the review of applications for temporary approval. It states that a temporary approval of water use may be approved if the Department determines that "other sources of water are not available," that the approval is in the public interest, and that the approval "will not injure public values associated with the water source or any other water right." Idaho Code § 42-202A does not establish a process to protest an application for temporary approval of water use. Persons wishing to raise objections or concerns related to the review criteria may do so in the form of a comment letter. If you have concerns about the proposed temporary water use, please deliver a comment letter to the Department on or before February 18, 2020. If you do not comment on the proposed temporary water use, the Department will assume that you have no objections to or concerns with the proposed temporary approval of water use. 



The district would like to divert water for ground water recharge at two locations during the winter months. The district holds Permits 34-7571 and 34-7573, which are limited by settlement agreement to only be available when the flow of the Big Lost River at the Arco gage is 60 cfs. During the winter months, there is usually not enough flow in the river to meet the 60 cfs threshold, even if the entire river is left in the river channel. We would like this temporary approval to be treated as a futile call diversion, to authorize ground water recharge when the 60 cfs threshold at the Arco gage could not be achieved, even with the full flow of the river below Mackay Dam. The district intends to keep the river live to Arco and would be open to a condition requiring that enough flow be left in the river to maintain a liver river channel to Arco.

WHEREAS, applications have been submitted to the Idaho Department of Water Resources to appropriate waters from the Big Lost River and tributaries for purposes of aquifer recharge, in the names of Mitchell Sorensen et al. (No. 34-07571) and Dave Nelson et al. (No. 34-07573) (hereafter, "Applicants"); and

WHEREAS, protests have been filed to said applications under I.C. § 42-203A et seq., by protestants U.S. Dept of Energy, Idaho Rivers United, Big Lost River Waterusers Association, Reva Walker, Charles Huggins, Dennis and Trudy Braswell, and Lester Braswell (hereafter, "Protestants"); and

WHEREAS, Applicants and Protestants all desire to see recharge occur in the Big Lost River valley in a manner which is both effective hydrologically and broadly benefiting all residents and interests in the valley; and

WHEREAS, Water District 34 has already agreed to accept assignment of and hold the recharge permits issued by the Idaho Department of Water Resources (IDWR), and to conduct recharge efforts pursuant to such permits; and

WHEREAS, Applicants and Protestants desire to facilitate successful recharge in 1997 and future years, and to resolve the pending protests amicably and without the need for hearing under the terms of this agreement; and

WHEREAS, Applicants and Protestants agree and stipulate that recharge efforts in the Big Lost River basin, if conducted according to the terms and conditions set forth herein, will serve the local public interest, conserve the water resources of the State of

4. Water District 34 shall, at its next regular or special meeting, confirm its acceptance of said recharge permits under the terms and conditions set forth herein. Failure to do so or rejection of any terms and conditions as set forth herein shall render this Settlement Agreement and Stipulation null and void, shall require IDWR to cancel the recharge permits, and shall reinstate the pending applications to the Applicants (without loss of priority date from the applications' filing), and shall reinstate the pending protests by the Protestants.

5. Upon issuance of said recharge permits by IDWR, those permits shall be held and implemented by Water District 34 strictly in accordance with Resolution No. 3-3-1997 of the water users of Water District 34 dated March 3, 1997, and the Plan of Operation, attached hereto and incorporated herein by reference as an integral part of this Settlement Agreement and Stipulation.

6. Following issuance of the recharge permits by IDWR and their acceptance by Water District 34, the terms and conditions of this Stipulation and Settlement Agreement shall be deemed fully satisfied. In the event of violation or failure to adhere to the terms and conditions of the Plan of Operation, the parties to this agreement may invoke or seek any available remedy or relief as provided by law. Any such violation or failure to adhere to the terms and conditions of the Plan of Operation for the Plan of Operation may also be raised by any party and considered by IDWR as grounds for denial of a license.

7 All parties shall bear their own costs and attorneys fees associated with the applications, protests, and administrative proceedings relating thereto. PLAN OF OPERATION BASIN 34 RECHARGE April, 1997

Introduction

This Plan of Operation is intended to implement the recharge effort in Basin 34 to accomplish the objectives of the water users of Water District 34 and the parties to the Settlement Agreement and Stipulation executed herewith. Recharge efforts utilizing water rights nos. 34-07571 and 34-07573 (recharge water rights hereinafter) shall be conducted in accordance with this Plan of Operation. Under this Plan of Operation the recharge water rights are to be used without regard for the relative priority between the two water right filings in a manner to fully and efficiently use the available water supplies and provide benefit throughout the basin.

The objectives of this Plan of Operation are to benefit all lands in the basin from flood water supplies that would otherwise exit the basin by maintaining reasonable river flows from the head of the valley to the Arco gaging station and the controlled diversion of otherwise unappropriated water into selected recharge sites. The expected basin wide project benefits are anticipated to be the following:

- 1) greater usage of flood water supplies.
- 2) flood control/stream bank protection.
- 3) recharge to natural springs and aquifer levels.
- 4) enhancement to fish and wildlife habitat and aesthetic values.
- 5) reduce damage caused by sub-water adjacent to river.
- 6) extended periods of river flows.
- 7) improved conveyance of diverted water supplies.
- 8) aquifer replacement of ground water supplies.
- 9) mitigation for senior surface water rights.
- 10) demonstration of community cooperation.
- 11) reduce or eliminate the need to curtail existing ground water rights.
- 12) maintain ground water levels for domestic wells.
- 13) develop greater understanding of ground and surface water hydrology in the basin.

Permit Terms and Conditions

The following terms and conditions relate to elements of the recharge water rights and are sought to be incorporated into the permits issued by IDWR for the recharge water rights. These terms and conditions remain integral parts of this Plan of Operation whether or not incorporated into the permits by IDWR.

Requirements and Guidelines for Recharge

Diversions of water for recharge shall be limited so as to not de-water (dry up) stream channels or increase the extent of de-watered stream channels at the time of the recharge diversion. Many tributaries to the Big Lost River and the Big Lost River itself do not have wetted channels for the entire length of the stream channel during portions of the year and during periods of drought. Among the purposes of this recharge plan is to retain water within the basin that would otherwise leave the basin downstream from the Arco gage as "flood flows." While retaining the water as high in the basin as possible may produce some benefit by extending the time the water may remain in the basin that added benefit does not off-set the value of recharging in the immediate vicinity of the stream channel itself to help maintain the integrity of The water supply required for maintaining wetted stream the stream channel. channels is self limiting since, as the ground water is recharged in the vicinity of the stream channel, smaller amounts of water will be required to maintain the stream and larger amounts of water will be available for diversion for other purposes. Additionally, the diversion of water for recharge from tributaries to the Big Lost River should not increase the amount of dry channel that exists for that tributary.

For the Big Lost River itself downstream from Mackay Dam, diversion for recharge downstream from Mackay Dam will not occur unless the flow at the Arco gage is 60 cfs or more measured as a three consecutive day average. The 60 cfs at the Arco gage is for purposes of this Plan of Operation only and is not and cannot be construed as a minimum flow or minimum flow water right under any theory of law.

In the event of a brief but intense weather event which is anticipated to produce flood flows for a period of three days or less, the Recharge Committee may call for and the Watermaster may deliver water for recharge purposes even if the flows at the Arco gage are below 60 cfs so long as the flow at the 2-B Gage is 300 cfs, or more, in excess of the non-recharge water deliveries occurring from the Big Lost River downstream from Mackay Dam.

Delivery of Water for Recharge

Delivery of water pursuant to the recharge water rights under this Plan of Operation is limited to the use of water for recharge purposes only and is subject to all prior water rights including, but not limited to, irrigation, stock water and storage. The Watermaster may, however, deliver water for recharge prior to the filling of all storage rights when the owner(s) of the stored water concurs that the reasonably anticipated runoff is sufficient to fill all storage rights and provide water for recharge.

Other Terms and Conditions

The following terms and conditions are not anticipated to be included by IDWR in the recharge water permits themselves, but nevertheless are integral parts of this Plan of Operation and the recharge effort undertaken pursuant to the Plan of Operation.

Control of recharge water rights

The recharge water rights shall be held and exercised by Water District 34 and are subject to the control of the Watermaster of Water District 34 (Watermaster hereinafter) for water distribution purposes pursuant to the Water Distribution Rules for Water District 34, the terms and conditions of this Plan of Operation, and all applicable laws and regulations. The Watermaster shall be guided and informed by the Recharge Committee, as set forth herein, regarding the control of the recharge water rights.

Delivery of recharge water shall be made to benefit the Big Lost River basin as a whole. As weather and water conditions change in the Big Lost River basin and as new recharge sites are developed, the Recharge Committee shall be guided by the goal to fully and efficiently use the available water supplies to provide benefit throughout the basin in the spirit of community cooperation and consensus.

Recharge Committee

Calls for delivery of recharge water will be made only by the Recharge Committee under the conditions and guidelines set forth herein. Calls for and delivery of recharge water will be according to this Plan of Operation and other applicable laws and regulations. Calls for delivery of recharge water by the Recharge Committee will be consistent with the intent of the water users of Water District 34 to provide benefits throughout the basin.

The Recharge Committee will have principal responsibility for selecting recharge sites and locations, dates for recharge efforts in any particular year, and for working with other entities (BLRID, BLM, land owners, etc.) to obtain the necessary permits and authorizations for use of recharge sites. The Recharge Committee may make recommendations to Water District 34 and the Watermaster about appropriate arrangements for obtaining authorization for use of recharge sites. The Recharge Sites. The Recharge Committee is urged to seek technical assistance, as required, from local, state, or federal natural resource agencies.

The Advisory Committee shall act promptly upon a complaint by any interested party that one or more members of the Recharge Committee should be removed for good cause. Good cause for removal of a committee member includes, but is not limited to, failure to diligently attend to the duties of the Recharge Committee, and failure to act in accordance with the goals or terms and conditions of this Plan of Operation.

Monitoring, Evaluation, and Accounting for Recharge

Recharge diversions will be accounted for by the Watermaster on an annual basis in a report to be submitted to the Recharge Committee and the Director of the Department of Water Resources. Only those flows diverted under the authority of the recharge water rights are to be accounted for as recharge. Canal seepage that occurs during the normal delivery of water pursuant to non-recharge water rights will not be counted as recharge.

Monitoring and study of the effects of recharge is a desirable part of this Plan or Operation. The Recharge Committee is encouraged to undertake a study, including monitoring and evaluation, to evaluate the effect of ground water recharge in the basin. The Recharge Committee is encouraged to seek the assistance and cooperation of local, state and federal agencies to complete the study.

Recharge and Mitigation

It is beyond the scope of this Plan of Operation to propose a specific mitigation plan that utilizes the recharge that will occur under this plan. Nothing in this plan, however, prevents any ground water user from proposing a mitigation plan to the Director of the Idaho Department of Water Resources, pursuant to Rule 50.04.c.iii or Rule 50.04.e of the Water Distribution Rules - Water District 34, IDAPA 37 Title 03 Chapter 12.

<u>Costs</u>

Water District 34 will be responsible for all costs associated with the recharge effort pursuant to this Plan of Operation including reimbursement of the application fees and other reasonable costs as provided by Resolution No. 3-3-1997 of the water users of Water District 34 dated March 3, 1997, and recharge facilities development and maintenance. Water District 34 may seek to defray these costs by seeking contributions from the beneficiaries of the recharge effort or by other means.

He asked for an explanation of what was being proposed in the Water District 34 Application for Temporary Water Use. I described the proposal. Mr. Walker said that he agreed that less water should be sent out to the desert. He explained that Reva Walker fought for years to get water back into the Spring Creek channel. Her objection to the original permit applications was focused on the Spring Creek channel. Mr. Walker is not opposed to the pending application, but wants the Water District 34 Recharge Committee to initiate a project to make Spring Creek an active waterway again. I suggested that Mr. Walker attend a meeting of the Recharge Committee and present his idea.
