

I met with Bill Curry of Power County Highway District and we made some changes and additions to the diversion points on TP-29-108 and TP-29-107. Power County is asking to increase the maximum daily volume from .106 AF to .322 AF on both. The total volume will remain 5.0 AF. I cannot see where any hardship would be experienced by any of the downstream surface water users. Williams, Hayball and Bodalak ditch is the closest diversion point to Power County's "**Stewart**" diversion point and I can monitor this for reduction of flow into the ditch.




