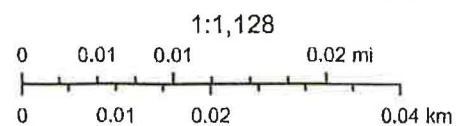


# Well #10 Point of Diversion

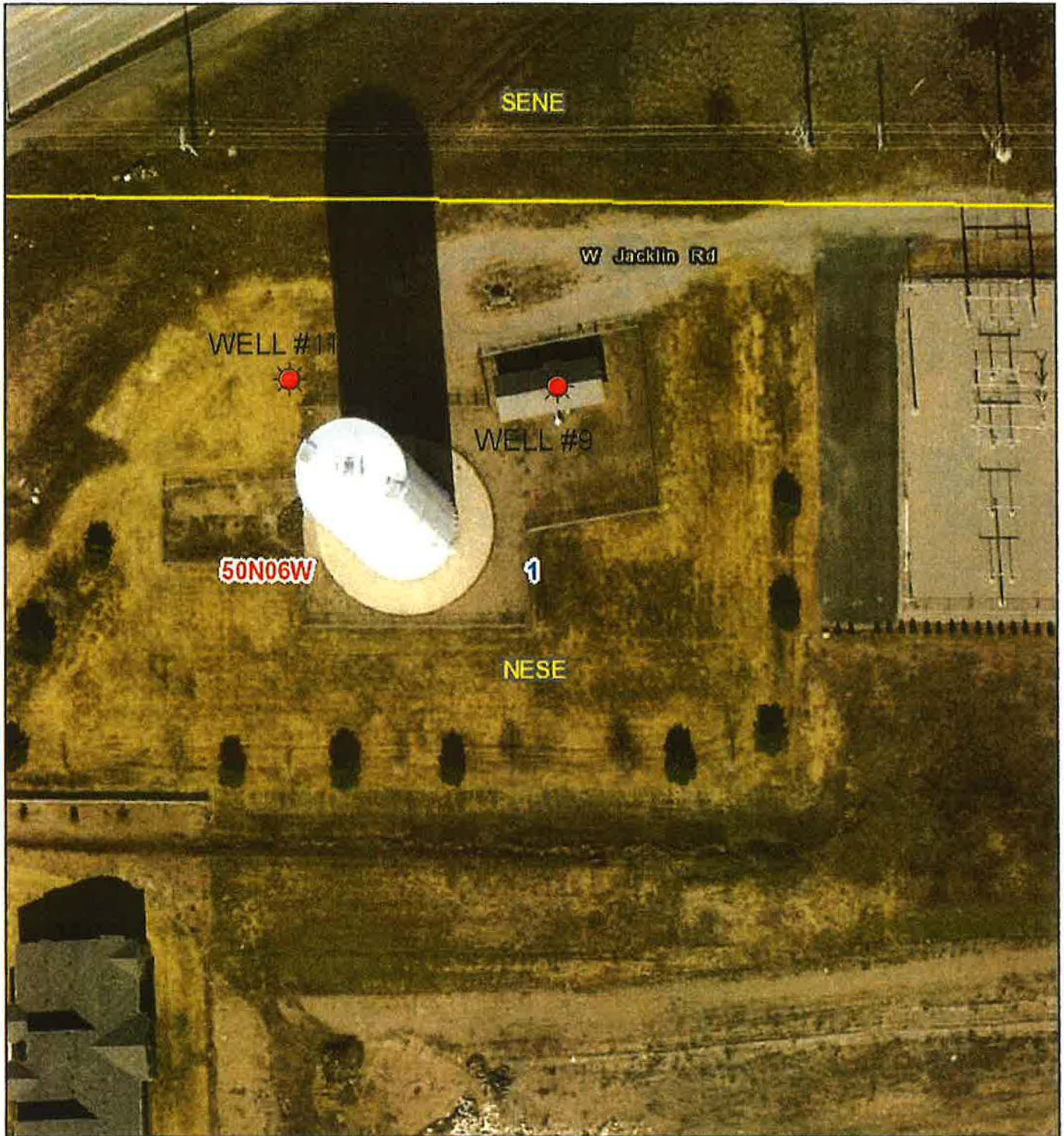

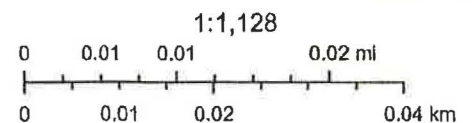


# Well #11 Point of Diversion

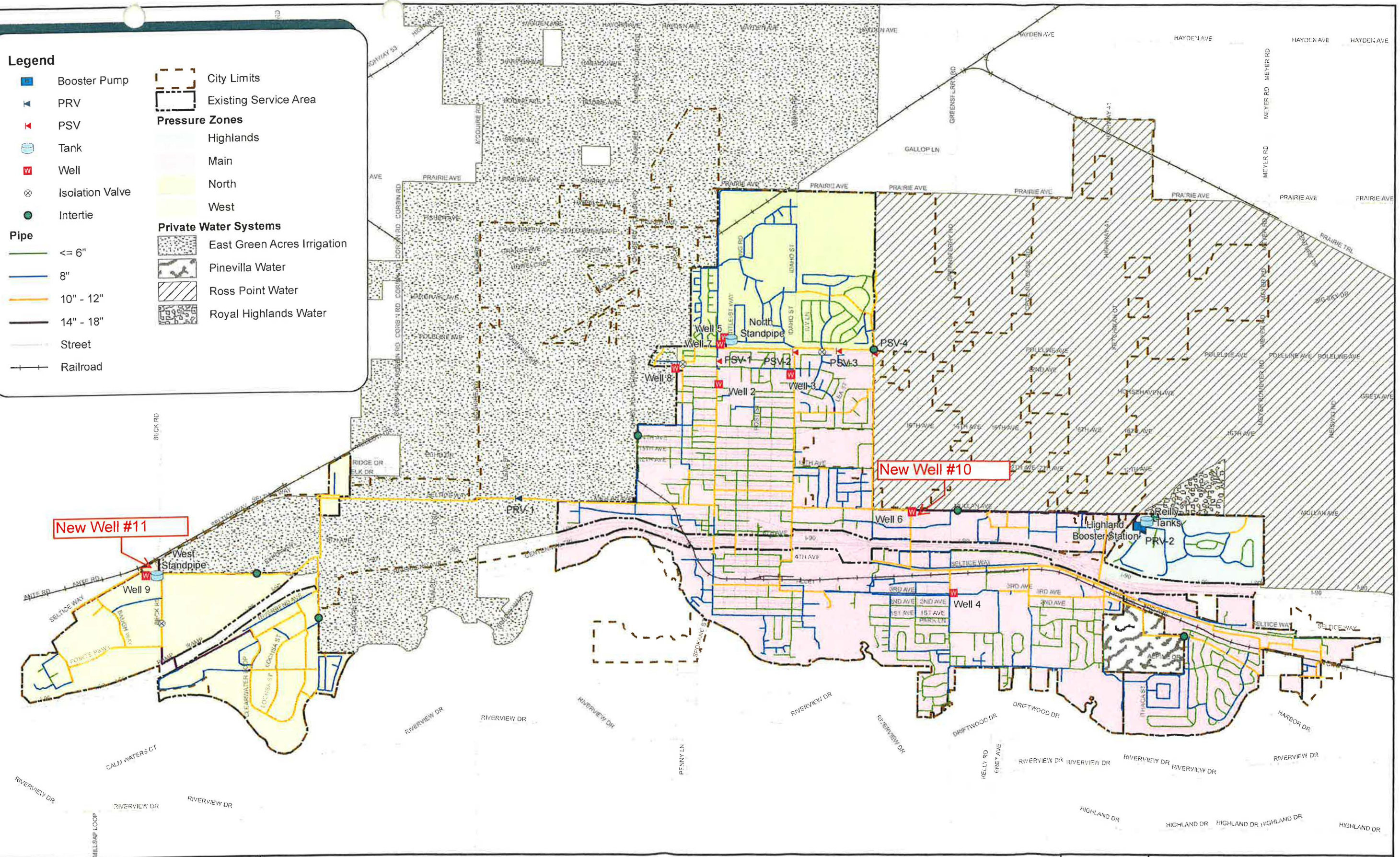

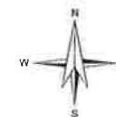

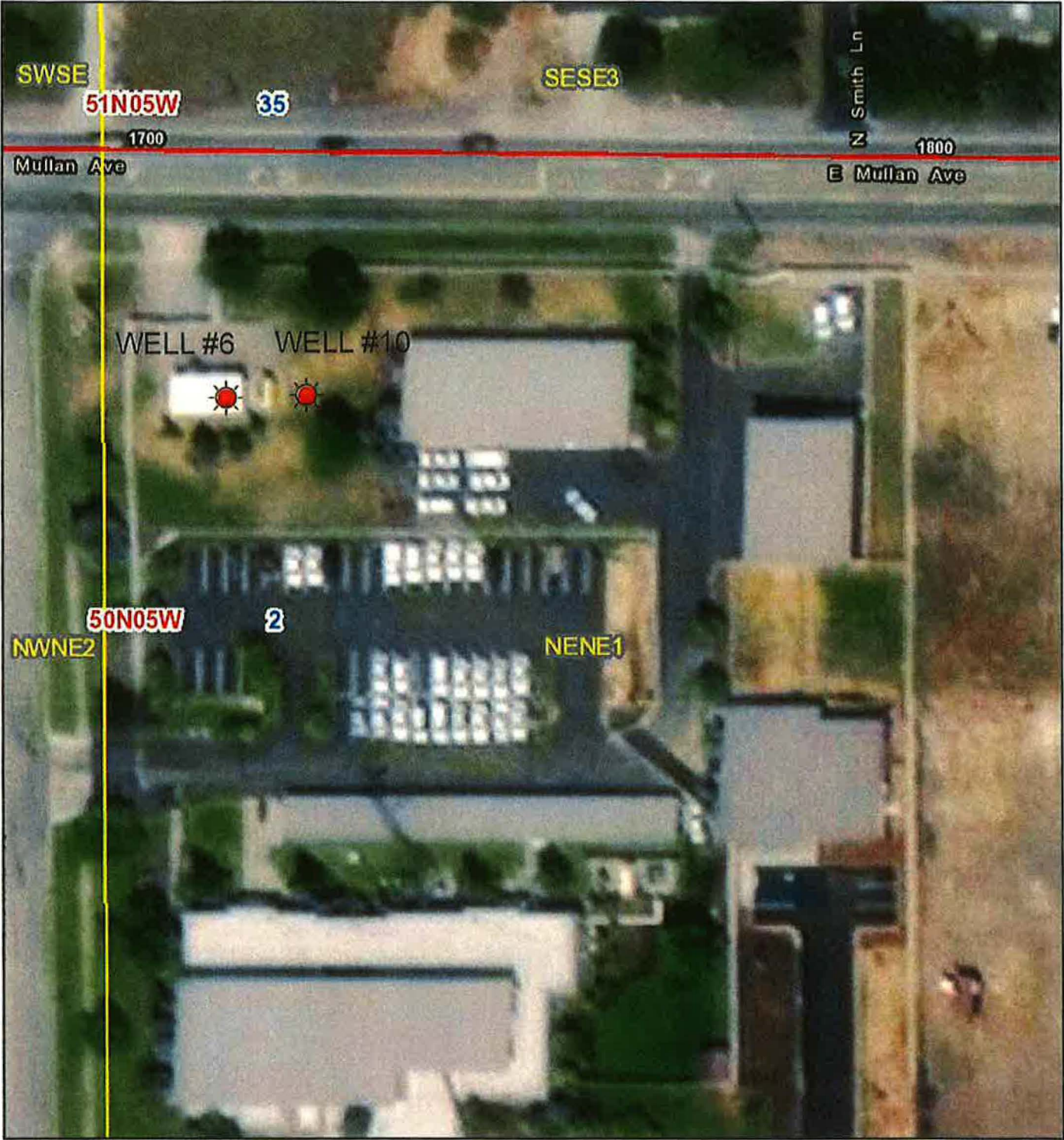

Existing System**

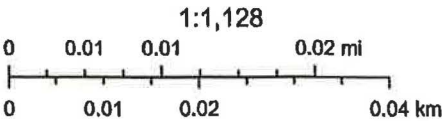

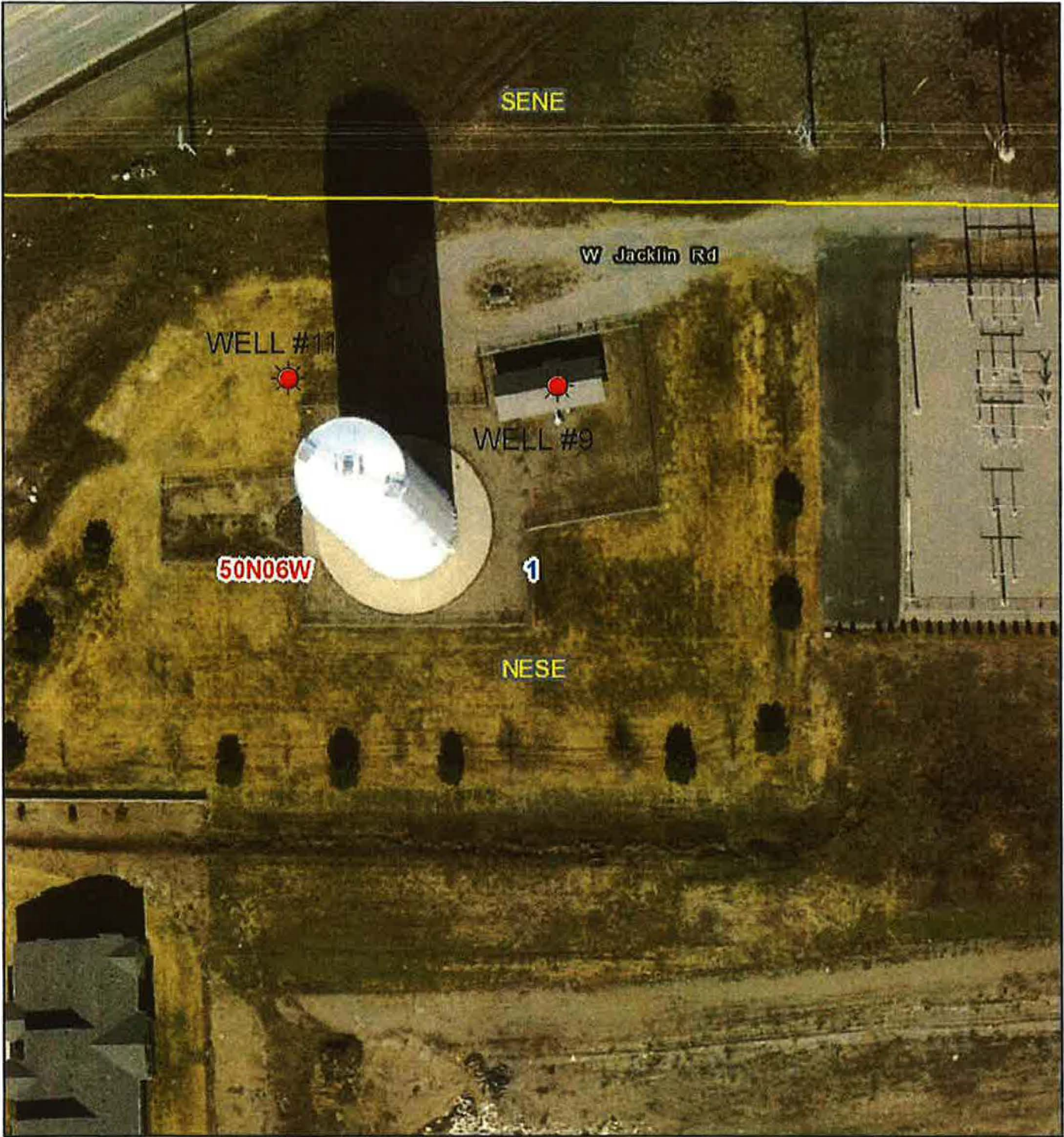

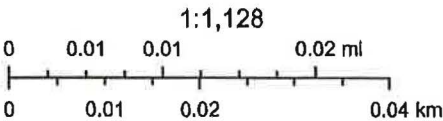


# Well #11 Point of Diversion

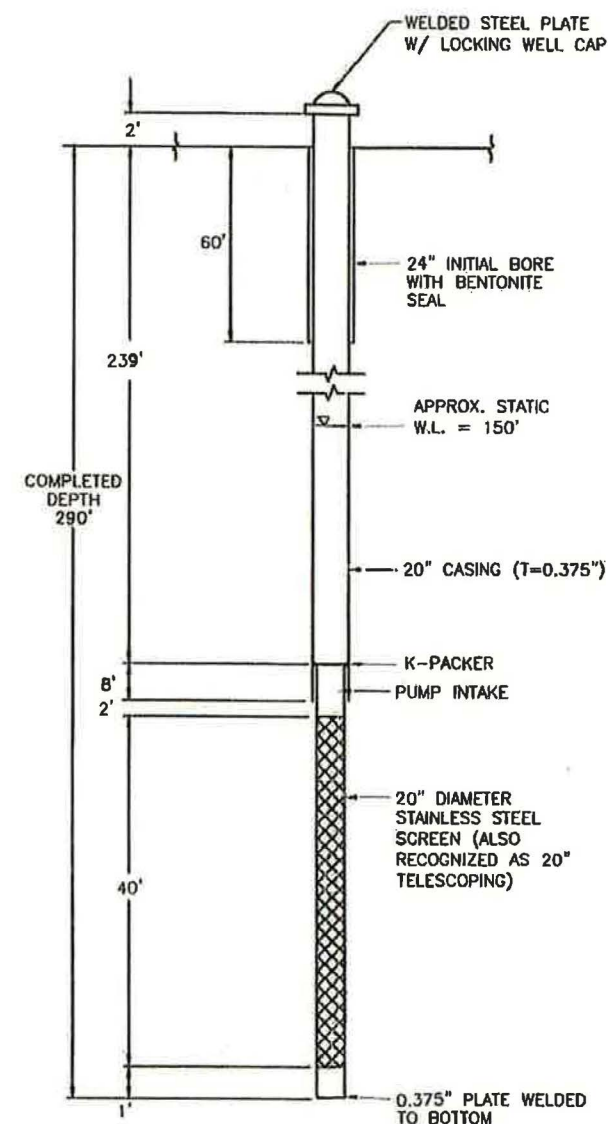

## CHAPTER 2.08 APPOINTED OFFICERS

SECTION:

**2.08.010: Appointment And Removal Of Appointed Officers**
**2.08.010: APPOINTMENT AND REMOVAL OF APPOINTED OFFICERS:**


The Mayor shall appoint as officers of the City, subject to approval of the City Council as provided by State law, a City Administrator, City Clerk, Finance Director, City Attorney, Chief of Police, **Public Works Director**, Human Resources Director, Community Development Director and a Parks and Recreation Director. Any officer appointed by the Mayor and confirmed by the City Council may serve in such position until removed in accordance with State law or by resignation. Appointed officers are generally subject to the City's adopted personnel rules, other than those provisions regarding appointment and removal, unless otherwise provided in an employment contract between the officer and the City or otherwise in conflict with City ordinances or State law. **The duties of the appointed officers are established by the adopted position description for each position.** Any contract between the City and an appointed officer shall serve the sole purpose of memorializing terms and conditions of employment and shall not establish employment of any particular duration, nor shall it modify any procedures for removal of an appointed Municipal officer established by provisions of Idaho law. (Ord. 1343, 2018)

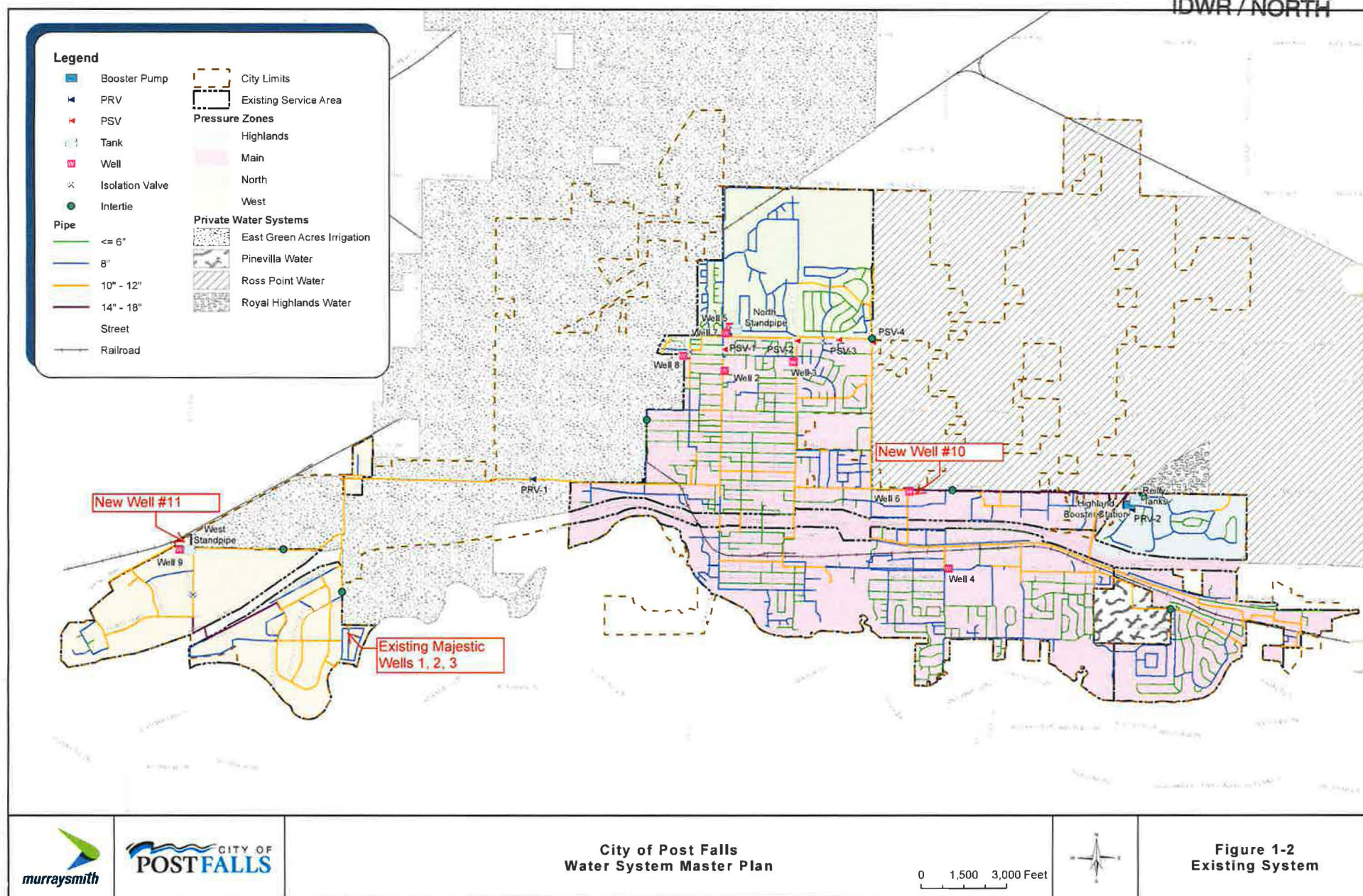
## Classification Summary

The primary function of an employee in this class is to serve as the executive leader in the Public Works Department which requires a variety of administrative, managerial and technical skills in planning, organizing, coordinating and directing the functions, activities and operations related to the Public Works Department. Supervision is exercised over division supervisors who manage diverse and complex operations and capital programs related to Public Works, Utilities and Building Maintenance. The Public Services Director works under the general direction of the City Administrator, but considerable latitude is allowed for independent judgment and initiative. The principal duties of the position are performed in a general office environment.

## Essential Duties and Responsibilities

- Works collaboratively with the Department Head Team to plan, budget, and schedule activities to meet Mayor and Council goals and mission;
- Plans, directs and leads the operations of the Public Works Department;
- Determines priorities, establishes goals and objectives, develops policies and procedures of the department;
- Coordinates efforts and projects which involve staff from multiple departments of the City which include Public Works;
- Contributes, with other Department Heads, to make policy recommendations to City Council regarding Citywide issues, including but not limited to personnel, budgetary, salary and benefits issues;
- Monitors the activities and functions of the department including reclaimed water, water, streets, storm water, street light utilities and facilities maintenance;
- Prepares and monitors the department budget;
- Prepares reports for Council actions;
- Assists public with complaints and issues relating to the Public Works Department;
- Represents the City for utility service interests at City, County, State, and Federal levels;
- Negotiate professional service contracts scope of work, schedule, cost, etc.;
- Administer design and construction contracts for capital projects;
- Supervise, evaluate, discipline, mentor, and train employees;
- Manage capital improvement projects and budgets;
- Provides research for community-wide programs including developing criteria and guidelines, draft ordinances or agreements for City Council's consideration.
