- Applicant received Notice: Statement of Completion Due dated October 31, 2019.
 In said statement, it says that a request for extension of time if the delay is for reasonable cause as provided in Section 42-204, Idaho Code.
- 2. Nest Egg Investments LLC c/o Aaron McCracken filed an extension of time on November 14, 2019. On the Extension of Time form, it requests... "Describe what work has been completed toward the development of this water right: If no work has been completed, show "none"." The Applicant did put down "None" on the basis of his lay interpretation of physical construction work completed at

the site which was true. However, the Applicant has expended numerous hours of work and money towards development of the water right. This includes:

- a. Purchased and transferred a water right and applied for the permit to divert required to operate the nursery business,
- b. Pursued and received zone change to C-1 commercial from Jefferson County,
- c. Pursued a change of the C-1 zoning ordinance to permit a garden/nursery with the C-1 zone,
- d. Designed a preliminary concept plan in preparation for having construction plans made,
- e. Worked diligently to complete purchase of the property.
- 3. As partially explained in the Request For Extension of Time, the Applicant's primary business location lost it's lease when the property was sold which required finding another location and constructing new infrastructure and moving. This included transferring a water right and drilling a new well at the new location. Time and money allocated to the Jefferson County location was required that it be set aside temporarily until the main nursery location was re-established.

For this purpose, Nest Egg Investments requests reconsideration and it be granted the extension of time for 5 years to complete the development of the water right permit.
