The department acknowledges receipt of correspondence correcting ownership changes previously complete for the above referenced water right(s). The department has created two separate contact IDs for Mojanet J Broadie (Deborah Broadie) and another for Mojanet James Broadie IV (Kelsey Broadie). The department has modified its records to reflect the correction and has enclosed computer-generated reports for your records.

Updating the ownership record for a water right does not reconfirm the validity of the right. When processing an ownership change notice, the department does not review the history of water use to determine if the right has been deliberately abandoned or forfeited through five years or more of non-use. To read more about water right forfeiture, including how to protect a water right from forfeiture, please see Sections 42-222 and 42-223, Idaho Code.

Also, please note that Section 42-248, Idaho Code, requires you or the owner of this water right to maintain current ownership and address records on file with the department.
