Attachment A

Notice of Abandonment of Water Right 36-8470

The Idaho Department of Water Resources (IDWR) was contacted by Mr. Donald Hayden regarding water right 36-8470. Mr. Hayden had received an annual assessment from Water District 130 and was inquiring if the water right was necessary. Upon investigation it appears WR 36-8470 was filed for 2.5 acres of irrigation (0.08 CFS) with a priority date of 9/12/1989.

Mr. Hayden indicated the property has been split into two parcels. Mr. Hayden retained 1.6 acres (parcel RP10S23E059381) and Mr. Jeff Stromire now is the owner of the other 1.4 acres (parcel RP10S23E059375). Based on the review the water right should be split between the two parcels, as follows:

Mr. Hayden has Minidoka Irrigation shares and does not use the well for irrigation. Mr. Stromire does not irrigate more than ½ acre and has no desire to irrigate the pasture. It appears each property would qualify for an exempt domestic use under Idaho Code 42-111. It is the desire of the owners to abandon this water right and utilize an exempt domestic use for in-house use and to irrigate no more than ½ acre.
