





On behalf of Sun Valley Land & Minerals Inc. (SVLM), Brockway Engineering is submitting six Water Supply Bank (WSB) lease applications which propose to lease all of water rights 37-4100, 37-4368B, 37-8205, 37-21614 and 37-22128 and a portion of 37-4369 to the Water Supply Bank for five years starting in 2020 and ending in 2024. The lease application for 37-4369 proposes to lease the portion of the storage component of the right that has been filled in by sedimentation from the Deer Creek drainage as a result of the Beaver Creek fire. The attached narrative explains in detail the method used to determine the amount of storage lost due to sedimentation by the fire. SVLM would like to be able to remove the sediment at a later date, necessitating the submittal of the attached WSB lease application.
