The Quitclaim Deed shows the property going from Spring Water LLC to Turquoise Mountain Holdings LLC. Spring Water LLC is not the same owner as the current owner of the water right who is Edward Bridges and Julia McCutcheon. The department will need another deed showing the property going from Bridges/McCutcheon to Spring Water LLC in order to sufficiently prove that Turquoise Mountain Holdings LLC is the current owner as quitclaim deeds are not reliable proof of ownership.

Evidence of Water Right Ownership: copy of Deed, Title Policy, Contract of Sale, or other legal document indicating your ownership of the property and/or water rights in question including a legal description of the property.

During our review of the documentation submitted, the department found that the Ownership Change form included had a copied signature not the real signature itself which is required. Also the Quitclaim deed shows the property going from Spring Water LLC to Turquoise Mountain Holdings LLC. Spring Water LLC is not the same owner as the current owner of the water right who is Edward Bridges and Julia McCutcheon. A chain of ownership is required showing the property going from Edward Bridges and Julia McCutcheon to Spring Water LLC in order for the ownership change to be processed.

Because the Department cannot process the Notice without proper documentation, we will hold any action on your notice pending receipt of the necessary information. If we do not receive the necessary information within 30 days (12/18/19) we will refund your notice and send back all attachments. Your notice will not be processed.

Also, please note that permit holders are required to report any change of ownership and/or mailing address to the Department within 120 days of the change. Failure to report these changes could result in a \$100 late filing fee. Forms to assign ownership or update your address are available from any office of the Department or on the Department's website.
