Mr. Sharp,

The Idaho Department of Water Resources (Department) is reviewing protested Applications for Permit. You submitted an Application for Permit on April 13, 2016 and was assigned Water Right No. 94-9480. Water Right No. 94-9480 was protested on June 20, 2016 by the Idaho Department of Fish and Game (IDFG). On April 25, 2017 a pre-hearing conference was held with the applicant and IDFG. A letter was sent to the applicant on September 20, 2017 which included an Amended Application for Permit and request for documentation of ownership or easement to store water and irrigate on lands not owned by the applicant. To date, the Department has not received any documents or response.

If you are still interested in pursuing Water Right No. 94-9480, please respond within thirty (30) days. If you are interested, a status conference will be setup due to the length of time from the pre-hearing conference. If you no longer wish to proceed with the water right process, please complete the enclosed withdrawal of application for permit form and return it to our office. If there is no response IDWR will issue a Preliminary Order denying the application. Please contact me at 208-762-2800 with any questions. Thank you for your attention to these matters.
