**ORDER DENYING
TEMPORARY CHANGE**

TC-34-93

WHEREAS, a drought emergency has been declared for Butte County to allow administrative actions to lessen the severe impacts of the drought conditions in the county; and

WHEREAS, section 42-222A, Idaho Code, provides that upon declaration of a drought emergency, the director of the Department of Water Resources (“Department”) is authorized to allow temporary changes in the point of diversion, the place of use, and the purposes of use for valid existing water rights or temporary exchanges of water authorized under water rights when the director determines that such changes can be accomplished in accordance with the provisions of section 42-222A, Idaho Code; and

WHEREAS, on May 28, 2010, J. Ryan Jones submitted the attached Temporary Change Application TC 34-93 to the Department; and

WHEREAS, the Department has reviewed the application and has determined the application CANNOT be approved;

ORDER

IT IS HEREBY ORDERED that the application is DENIED based on the following information:


1. The application states that the owner of the surface water rights proposed to be transferred, Richard Cole, will not use those water rights and will instead use his ground water right to irrigate his property.
2. Richard Cole has five water rights associated with the property in question (34-65A, 34-377D, 34-840, 34-841, and 34-2379C). Water right 34-2379C is for ground water. The rest of the water rights are from the Big Lost River.
3. Water rights 34-65A, 34-377D, 34-840, 34-841, and 34-2379C combined are limited to the irrigation of 111 total acres within an irrigation season. In a phone conversation, Mr. Jones stated that Mr. Cole intended to irrigate all of his acres using his ground water right.
4. Allowing Mr. Cole to irrigate 111 acres with ground water and transfer his surface rights to Mr. Jones to irrigate additional acres would be a violation of the conditions of Mr. Cole’s water rights and an enlargement of his water rights.

5. In a telephone conversation, Mr. Jones noted that an identical temporary change application was approved in 2007. Given the described acreage limitations associated with Mr. Cole's water rights, that application should not have been approved.


