WHEREAS, a drought emergency has been declared for <u>Batte</u> County to allow administrative actions to lessen the severe impacts of the drought conditions in the county; and

WHEREAS, section 42-222A, Idaho Code, provides that upon declaration of a drought emergency, the director of the Department of Water Resources ("Department") is authorized to allow temporary changes in the point of diversion, the place of use, and the purpose of use for valid existing water rights or temporary exchanges of water authorized under water rights when the director determines that such changes can be accomplished in accordance with the provisions of section 42-222A, *Idaho Code*; and

WHEREAS, on August	13,2004	Keith	Waddow	submitted
the attached Temporary Cha	nge Application	<u>TC-34-5</u>		epartment; and

WHEREAS, the Department has reviewed the application and has determined the application can be approved with certain conditions;

ORDER

IT IS HEREBY ORDERED that the application is **APPROVED** subject to the following conditions:

- 1. Diversion and use of right no(s). <u>34 2417A</u> is authorized only at the point of diversion and place of use described on the application.
- 2. This temporary Change approval does not authorize construction of a new well as a new point of diversion.
- 3. The applicant assumes all risk of curtailment or mitigation should the diversion and use of water under the temporary change approval cause injury to other water rights, constitute an enlargement in use of the original right, be inconsistent with the conservation of water resources within the state of Idaho, or not be in the local public interest.
- 4. This temporary change approval may only be used to provide a replacement water supply to lands or other uses that normally have a full water supply, except for the drought condition. This temporary change approval may not be used to provide water for new development or to allow expansion of the use of water under existing water rights.

- 11. The Water master of Water District No. <u>34</u> is authorized to administer the temporary change approval.
- 12. This Temporary change approval expires on <u>October 31</u>, <u>2004</u> unless rescinded or extended by the director. Thereafter, the water right shall revert to the point of diversion, place of use, and nature of use existing prior to the temporary change approval.

Comment: NOTICE OF ERROR REGARDING COMBINED DIVERSION RATE: INITIAL RECOMMENDATION DID NOT RECOGNIZE A CONVEYANCE LOSS WITH THE GROUNDWATER RIGHT (34-02416D). THIS RIGHT IS CARRIED TO THE PLACE OF USE VIA BLIRD CANALS (MOORE CANAL) AND IS CHARGED THE CUSTOMERY CONVEYANCE LOSS. I RECALCULATED THE COMBINED ALLOWABLE DELIVERY RATE TO BE 2.29 CFS. I MADE THIS CHANGE TO THIS RIGHT AS WELL AS RIGHT NOS. 34-00622D AND 34-02416D. REGARDING 34-02416D I ALSO CHANGED THE DIVERSION VOLUME TO 400 ACRE FEET WHICH INCLUDES A 30% INCREASE FOR CONVEYANCE LOSSES. NOTICE OF ERROR REGARDING REQUESTED CHANGE OF PLACE OF USE: CLAIMANT REQUESTED THAT WE COMBINED THE PLACE OF USE FOR RIGHTS 34-02416D, 34-00311A & 34-00622D WITH THAT OF RIGHTS 34-00216A, 34-00787 & 34-00925B. THE CLAIMANT PURCHASED THE PROPERTY UNDER 34-02416D, ETAL IN 1990. I DISCUSSED THAT SINCE THE PROPERTY TRANSFER OCCURRED AFTER 1987, WE COULD NOT RECOMMEND AN ACCOMPLISHED CHANGE OF POU. FURTHER, THE CLAIMANT STATED THAT THESE RIGHTS WERE NEVER USED IN COMBINATION PRIOR TO 1987.
