drought emergency, the director of the Department of Water Resources ("Department")
is authorized to allow temporary changes in the point of diversion, the place of use, and
the purpose of use for valid existing water rights when the director determines that such
changes can be accomplished in accordance with the provisions of section 42-222A,
Idaho Code; and

WHEREAS, on 6/9/03, Churndasher Ranch
Scott Johnson submitted the attached
Temporary Change Application TC-34-23 to the Department; and

WHEREAS, the Department has reviewed the application and has determined
the application can be approved with certain conditions;

ORDER

IT IS HEREBY ORDERED that the application is **APPROVED** subject to the
following conditions:

1. Diversion and use of right no(s). 34-611A, 34-612A,
34-613A, 34-803 is authorized only
at the point of diversion and place of use described on the application.
2. This temporary change approval does not authorize construction of a new
well as a new point of diversion.

injury to other water rights, constitute an enlargement in use of the original
right, be inconsistent with the conservation of water resources within the

**Re: Orders Authorizing Temporary Changes TC-34-23 (Johnson)
and TC-34-32 (Unger)**

Dear Bob:

I am writing on behalf of David Stoecklein concerning the delivery of water pursuant to the above-referenced temporary changes under the drought emergency. Mr. Stoecklein is concerned that your delivery of the temporarily changed water rights in both cases is not in compliance with condition no. 4 of each Order. This condition, which is required by the provisions of Idaho Code § 42-222A(6), reads as follows:

This temporary change approval may only be used to provide a replacement water supply to lands or to other uses which normally have a full water supply, except for the drought condition. This temporary change approval may not be used to provide water for new development or to allow expansion of the use of water under existing water rights. (Emphasis added)

In the case of the Unger temporary change, it is our understanding that you are delivering the full amount of the temporarily changed water rights (82 inches) together with the full amounts of water rights 34-469 and 34-471 (200 inches) to the Upper Fish Hatchery Canal headgate. The last two water rights provide the normal full water supply to the lands identified in the Order Authorizing Temporary Change to be irrigated by the 82 inches. Therefore, the 82 inches is not acting as a "replacement water supply" and, the place of use under the Order has its normal water supply.

For Johnson, water right nos. 34-860A, 34-859A and 34-573A provide the normal water supply to the irrigated lands identified in the Temporary Change Application. It is our understanding you are continuing to deliver into the Shoup Ditch the entire amount of these three water rights together with the Parsons Creek water rights which, pursuant to the Order Authorizing Temporary Change, may only be delivered as a "replacement water supply."

Please understand we are in no way contesting the fact that there is, indeed, a drought emergency in Butte County and that temporary water right changes pursuant to the provisions of Idaho Code § 42-222A are proper vehicles to obtain replacement water for lands which would, except for the drought, have a full water supply. However, these changes may not be used to deliver additional water to the same lands which already have their normal full supply of water. We are particularly concerned when the result is to dry up the creeks running through Mr. Stoecklein's property.

We ask that you request appropriate officials at the Idaho Department of Water Resources to provide you with direction on the interpretation and enforcement of condition no. 4 of each of these two Orders Approving Temporary Changes. I have briefly discussed these matters with Ron Carlson and he agrees with my interpretation of the Orders Authorizing Temporary Changes. The delivery of these water rights directly impacts my client's property. Please keep me apprised of the directions you are given by the Department.

Enclosed is Check #4471 in the amount of \$50.00 and the "Temporary Change Application" for the above numbered water rights.

A temporary change cannot result in an enlargement of water use under the rights. An equal amount of use needs to be given up, usually in terms of acreage that will not have a full water supply during the period of the temporary change. As proposed on your application there is not a reduction in acreage only a rotation between the sources (Parsons Creek and Warm Springs Creek.) This would appear to be an expansion of the water rights, which could affect other water users on Parson Creek and Warm Springs Creek. In addition the place of use as described on the application is incorrect (note enclosed land list for these water rights.)

In addition this office must also obtain and consider comments of the watermaster prior to approval of the temporary change.
