Re: Protestant Inventory and Status

The Idaho Water Resource Board filed multiple applications for ground water recharge use in 1998 that were protested and processing was delayed. Initial review of the applications resulted in some renumbering and consolidation of applications as described on the IWRB Recharge Contested Applications summary sheet found in each of the remaining active application files. Protests for two of the active applications were resolved in 2017 and permits were issued for 1-7142 and 1-10609. Of the 20 originally advertised applications, applications 1-10612, 1-10613, 21-7577, 21-7578, 21-7580 and 21-13160 remain active and pending resolution.

Many of the protests received in 1998 were for all or many of the 20 applications. The original common protests are located in water right file 1-7142, the lowest number application following renumbering and consolidation of applications. In order to be confident all the protestants and intervenors were correctly identified for each application, a thorough research of all of the application files was conducted in 2017.

I reviewed documents from original water right files 21-7577, 21-7578, 21-7580 and associated files for applications submitted at the same time to determine the history of each protest related to these active applications. The review identified seven remaining active protestants and two intervenors as shown on the spreadsheet dated August 30, 2017 labeled as an attachment to this memo.

Water Right files 21-7577, 21-7578, 21-7580 include copies of eight protests and one petition to intervene filed in 1998 following initial advertising of the original 20 applications listing these applications. These documents are located in chronological order on the bottom of the right side of the file following a copy of the original 1998 advertisement located in 1-7142. One additional petition to intervene was filed in 2013 specifically for each application following advertisement of the other consolidated applications and is located chronologically on the right side of the file.
